Pursuant to Regulation 30 of Listing Regulations read with SEBI Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/84 dated 20th May, 2020 and in continuation to our earlier relevant disclosure on the subject on 27th March, 2020, we would like to inform the following details relating to the impact of the COVID-19 pandemic and the resultant lockdown, on the operations of the Company:

1. Impact of the COVID-19 pandemic, ability to maintain the operations, schedule, if any, for restarting the operations and steps taken to ensure smooth functioning of operations:

In view of the lockdown across the country in mid March, 2020, the manufacturing facilities of the Company were working partially till the first week of April, 2020. As the Company is in the manufacture and sale of pharmaceuticals intermediaries, after discussing with authorities and sorting out the bottlenecks, the Company then gradually ramped up its operations over the next several days till April end and efforts are on to achieve optimum capacity production in May, 2020.

The Company is ensuring compliance with the directives issued by the Central Government, State Governments and local government. All the manufacturing facilities have been sanitized so that our employees are safe and secure. All safety protocols of temperature sensing, wearing of safety gears (masks, goggles, face shields), social distancing, sanitizing and washing hands are being adhered to very stringently.

Our Registered Office in Vashi and Corporate Office in Mumbai are closed in accordance with the Government directives. R & D centre in Pune has resumed working from 27th May, 2020 with limited strength. All employees in our offices are working from home. The company remains committed to the health and safety of its employees, their families and communities in which they operate.

2. Financial resources, profitability, liquidity position, ability to service debt and other financing arrangements, assets, internal financial reporting and control and demand for products/services:

The Company is in a comfortable financial position to meet its commitments and will be able to meet all its debts obligations as they come up. Stringent cost control measures are being implemented across the organization to address any evolving situation resulting from the pandemic. The Company has secured all its assets and are in working condition. Internal financial reporting and control are adequate and operating effectively. The Company expects that the demand for its products from pharmaceuticals sector will continue.
