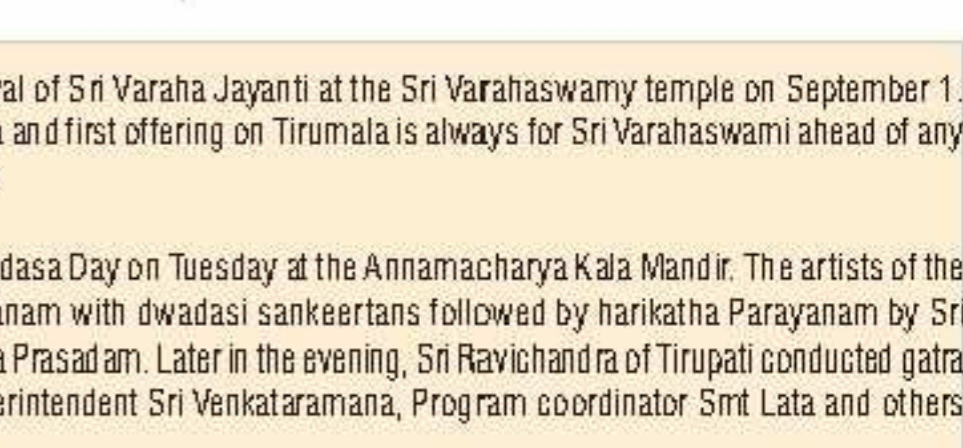
FOUNDATION DAY-NFL
