सड़कों से गायब हो रही पीली टैक्सी

कोलकाता, २४ मार्च (जनसत्ता)।

महानगर में चलने वाली पीली टैक्सी शहर की परंपरा से जुड़ी है, लेकिन जैसे-जैसे समय बीत रहा है महानगर में पीली टैक्सियों का प्रचलन कम होता जा रहा है। इसका एक मात्र कारण है ऐप आधारित टैक्सी। आज के लोग ऐप आधारित टैक्सी पर इस तरह निर्भर हो गए है कि पीली टैक्सी की मांग कम हो गई है।
