This is to inform you that on 25<sup>th</sup> January 2024, "Exide Industries Limited" ('Company/EIL') has invested Rs.50,00,00,023/- (Rupees fifty crores and twenty-three only) by way of subscription in the equity share capital of its wholly owned subsidiary, "Exide Energy Solutions Limited" (hereinafter referred as 'EESL'), on rights basis. With this investment, the total investment made by the Company in EESL stands to Rs. 1,870.01 crore. There is no change in the shareholding percentage of the Company in EESL pursuant to such an acquisition.
