I sincerely thank my Mentors and colleague for their valuable guidance and co-operation extended during the tenure of my office in the Company.

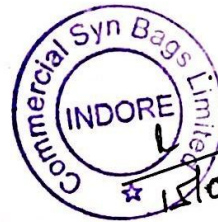
