

**Sub: Consolidated Scrutinizer's Report on E-Voting during 32<sup>nd</sup> Annual General Meeting of the Sharpline Broadcast Limited held through Video Conferencing(VC)/ Other Audio Visual Means (OAVM) on Thursday, 15<sup>th</sup> September, 2022 at 12:00 P.M.**

I, Vivek Kumar (M.No. F8976, C.P. No. 10438), Proprietor of V Kumar & Associates, Company Secretary in Practice, having its office at 15/18 Basement, West Patel Nagar, New Delhi-110008, had been appointed as a Scrutinizer by the Board of Directors of **Sharpline Broadcast Limited** vide board resolution dated 17<sup>th</sup> August, 2022 for the purpose of scrutinizing the e-voting process and ascertaining the requisite majority on the proposed business contained in the Notice of Annual General Meeting of Sharpline Broadcast Limited held on Thursday, 15<sup>th</sup> September, 2022 at 12:00 P.M. at through video conferencing (VC)/ other audio visual means (OAVM) pursuant to the provisions of Section 108 of the Companies Act 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended and in accordance with Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015. My responsibility as a Scrutinizer for the e-voting process is restricted to make a scrutinizer report based on the reports generated from the e-voting system provided by National Securities Depository Limited.

My report on the scrutiny of the e-voting is as follows:-

1. The AGM is held in compliance with the applicable provisions of the Companies Act, 2013 and the Rules made thereunder read with the MCA General circulars dated May 5, 2020, April 8, 2020 and April 13, 2020 (collectively referred to as "MCA Circulars") and SEBI Circular dated May 12, 2020. Further as confirmed by the company the Notice of the AGM was sent only through electronic mode to those Members whose e-mail addresses were registered with the Company/Registrar and Transfer Agents (RTA).
2. The Compliance with the applicable provisions of the Companies Act, 2013 and the Rules made thereunder relating to electronic voting (which includes remote e-voting and e-



voting conducted during the AGM) on the resolutions proposed in the Notice calling the AGM of the Company was the responsibility of the management. My responsibility as a scrutinizer was to ensure that the voting process is conducted in a fair and transparent manner and render Scrutinizer's Report related to electronic voting.

3. The facility for e-voting during the AGM was provided by National Securities Depositories Limited. The e-voting period remained open from Monday, 12<sup>th</sup> September, 2022 at 09.00 A.M. (IST) and ends on Wednesday, 14<sup>th</sup> September, 2022 at 05.00 P.M. (IST). At the AGM of the Company held on Thursday, 15<sup>th</sup> September, 2022, during the AGM announced that the e-voting facility has been provided to facilitate voting for those members who attended the meeting through VC/OAVM but could not participate in the remote e-voting to record their votes on the resolutions to be passed.

4. The shareholders holding shares as on the "cut off" date i.e. 02<sup>nd</sup> September, 2022 were entitled to vote on the proposed resolution as set out in the Notice of Annual General Meeting (AGM) of Sharpline Broadcast Limited.

5. After the closure of the e-voting facility provided during the AGM, the votes were unblocked on the presence of two witnesses who are not in the employment of the Company and a final electronic report was generated by me. The data generated was diligently scrutinized.

6. Thereafter, the details, containing, inter-alia, list of equity shareholders, who voted "For" and "Against", were downloaded from the e-voting website of National Securities Depository Limited (<https://www.evoting.nsdl.com>)

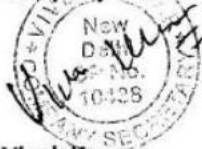
