Noida set to take private help to monitor NCLT cases and land dues

Noida. The Noida Authority is planning to hire a consultancy firm to monitor its escrow accounts, reviewing insolvency cases under the National Company Law Tribunal (NCLT), and assisting with internal coordination, among other tasks. The consultant will help execute escrow agreements and provide updates on insolvency proceedings. The Authority has issued a Request for Proposal (RFP) for consultancy services and interested firms can submit their bids by Feb 18, after which the technical evaluation will take place the following day. Initially, the company will be hired for one year. The Authority allots land parcels on a lease basis for development under specified agreements. However, several developers have failed to adhere to the terms, delaying project execution and defaulting on land payments. To curb such defaults, the Authority intends to introduce an escrow mechanism that

will ensure timely settlement of dues when third-party rights are created through the sale of units, apartments, or plotted developments. The appointed consultant will assist in drafting and executing escrow agreements while regularly monitoring fund flows. The introduction of escrow accounts is part of a broader strategy to recover outstanding dues from defaulting developers, who collectively owe the Authorities. against the misuse of buyer funds, preventing developers from diverting resources to other projects instead of settling their financial obligations with the Authority, officials explained. Apart from overseeing escrow accounts, the consultant will also play a crucial role in monitoring companies undergoing insolvency proceedings. The Authority requires real-time updates on cases being heard at the NCLT, particularly for firms that are at risk of insolvency but have not yet entered formal proceedings. By tracking these developments, the Authority will

be able to make informed decisions and take pre-emptive measures where necessary. For companies already facing insolvency, the consultant will assist in filing claims, coordinating with the Committee of Creditors (CoC), and ensuring active participation in the resolution process. A total of 17 group housing projects in the city are currently undergoing NCLT proceedings, making it essential for the Authority to closely monitor developments and safeguard its financial interests, officials added.

Shops, road network, farmhouses razed in anti-encroachment drive

Gurgaon. A large-scale demolition drive was conducted by DTCP on Tuesday, targeting unauthorised colonies and structures with heavy police deployment in Sohna Sadar Nimoth Chowki.

The authorities also razed an illegal colony on 2 acres, demolishing three under-construction shops, a dealer office, and road networks. Another illegal colony in 2.5 acres saw a 200m boundary wall and an under-construction structure demolished in Karanki village.

Also, two unauthorised farmhouses — spanning 2 and 5 acres — were dismantled, with gates, guard rooms, awnings, cabanas and swimming pools destroyed. Officials emphasised strict action against encroachments, warning the land mafia against illegal developments in controlled areas.

This demolition drive is part of a larger effort to regulate unauthorised expansion in the city's outskirts, where illegal plotting and farmhouses have proliferated despite legal restrictions. Officials stated that the drive will be continued against unauthorised constructions and developers and land mafia involved in such activities will face serious consequences. They have also urged residents to verify land approvals before purchasing properties to avoid financial losses as well as landowners to ensure proper approvals from regulatory bodies before constructing properties in controlled areas. नई दिल्ली (न्यूज वाता) नई दिल्ली में श्री अरुण बनर्जी (ए ओ आर, सुप्रीम कोर्ट ऑफ इंडिया, केंद्र सरकार, उत्तर प्रदेश सरकार के वकील) द्वारा मानवाधिकार जागरूकता अभियान पोस्टर का लोकार्पण। जूडिशियल कॉउन्सिल के चेयरमैन श्री राजीव अग्निहोत्री ने कहा मानवाधिकार वे नैतिक सिद्धान्त हैं जो मानव व्यवहार से सम्बन्धित कुछ निश्चित मानक स्थापित करता है। ये मानवाधिकार स्थानीय तथा अंतरराष्ट्रीय कानूनों द्वारा नियमित रूप से रक्षित होते हैं। ये अधिकार प्रायः ऐसे 90%आधारभूत अधिकारों जैसे जिन्हें प्रायः 90% लोग जानें जाने योग्य माना जाता है और यह भी माना जाता है कि अधिकार किसी व्यक्ति के जन्मजात अधिकार हैं। व्यक्ति के आयु, प्रजातीय मूल, निवास-स्थान, भाषा, धर्म, आदि का इन अधिकारों पर कोई प्रभाव नहीं होता है। ये अधिकार सदा और सर्वत्र देय हैं तथा सबके लिए समान हैं। मानवाधिकारों को लेकर अक्सर विवाद बना रहता है। ये समझ पाना मुश्किल हो जाता है कि क्या चाकड़ों

में मानवाधिकारों की सार्थकता है। यह किताब दुर्भाग्यपूर्ण है कि तमाम प्रादेशिक, राष्ट्रीय और अंतरराष्ट्रीय स्तर पर सरकारी और गैर सरकारी मानवाधिकार संगठनों के बावजूद मानवाधिकारों का परिदृश्य तमाम तरह की विसांगतियों से भरा पड़ा है। भारतीय संविधान इस अधिकार को सिर्फ गारंटी देता है, बल्कि इसे तोड़ने वाले को अदालत सजा देती
