## Shops, road network, farmhouses razed in antiencroachment drive

Gurgaon. A large-scale demolition drive was conducted by DTCP on Tuesday, targeting unauthorised colonies and structures with heavy police deployment in Sohna Sadar Nimoth Chowki.

The authorities also razed an illegal colony on 2 acres, demolishing three under-construction shops, a dealer office, and road networks. Another illegal colony in 2.5 acres saw a 200m boundary wall and an underconstruction structure demolished in Karanki village. Also, two unauthorised farmhouses — spanning 2 and 5

acres — were dismantled, with gates, guard rooms, awnings, cabanas and swimming pools destroyed. Officials emphasised strict action against encroachments, warning the land mafia against illegal developments in controlled areas.

This demolition drive is part of a larger effort to regulate unauthorised expansion in the city's outskirts, where illegal plotting and farmhouses have proliferated despite legal restrictions. Officials stated that the drive will be continued against unauthorized constructions and developers and land mafia involved in such activities will face serious consequences. They have also urged residents to verify land approvals before purchasing properties to avoid financial losses as well as landowners to ensure proper approvals from regulatory bodies before constructing properties in controlled areas.Local authorities emphasized their commitment to eradicating illegal developments in controlled areas.

Experts believe such actions will deter illegal land transactions and ensure strict compliance with zoning regulations. However, affected landowners have raised concerns, with some claiming they were unaware of the illegal status of their properties. As authorities continue the encroachment crackdown, more demolition drives are expected in the city's outskirts.

# 27-yr-old shot at outside his home, injured

Noida. A 27-year-old man was shot in the leg by unidentified assailants outside his house in Nangla Chamru village on Tuesday night. Police suspect the attack was linked to an old enmity.

The incident occurred around 10pm, following which a team from Jarcha police station reached the spot. A senior officer said the injured, Ankit, was rushed to a nearby hospital by his family. "He sustained a bullet injury in his leg but is out of danger," the officer said.

Protection and promotion of human rights is sine qua non - Judicial Council

New Delhi: 13 February (News Varta) Protection and promotion of human rights is sine qua non Judicial Council Launch of Human Rights Awareness Campaign Poster by Shri Arup Banerjee, (AOR Supreme Court of India, Advocate for Central Government, Standing Counsel of Uttar Pradesh) in New Delhi at Supreme Court . Chairman of Judicial Council Shri Rajiv Agnihotri said that Human Rights are those moral principles which establish certain standards related to human behaviour. These human rights are regularly protected by local and international laws These rights are often such 'basic rights' which are often considered 'inalienable' and it is also believed that these rights are the innate rights of a person. The age, racial origin, place of residence, language, religion, etc of the person have no effect on these rights. These rights are always and everywhere due and are equal for everyone. There is often controversy over "human rights". It becomes difficult to understand whether



human rights really have any meaning. It is unfortunate that despite the existence of governmental and non-gov ernmental human rights organizations at the regional national and international levels, the human rights are violated. The Indian Constitution not only guarantees this right, but the court also punishes those who violate it. There are many people who say that every moment of life should be dedicated to the nation, human rights and society. But people who live their entire life in this way are rarely seen and the life of Arup Bannerjee ji is one such example. Shri Agnihotri said that Shri Arup Banerjee ji has worked to establish the principle of 'Human rights ' in the field of justice. Shri Banerjee said, "It is not easy to define human rights or human right. But it cannot be denied either. Many differences are found at many levels in human society. Language color, mental level, racial level etc., discrimination is practiced in human society at these levels. "Despite all this, some essentials are common in all societies. These essentials are human rights which a person should get by being a human being." According to Advocate Supreme Court of India Shri. Priyanshu Raj, "Human rights are those rights of a person without which a human cannot even think about the full development of his personality, which are inherent in a human being as a result of being a human being. Which he should definitely get by being a human being. I feel very proud to be a part of the poster launch of Human Rights Awareness Campaign by Judicial Council and I would like to thank that I became a part of it. Shri. Amitabh Poddar, Advocate Supreme Court of India "Human rights are rights given by nature, therefore, despite changes in time and circumstances, there is no significant change in the nature of rights. Human rights are also called natural rights. That is, some rights become a part of human nature. Rights guarantee freedom to a person, freedom from exploitation and atrocities and create an environment in society in which everyone gets proper opportunities for personality development. Finally Shri Agnihotri said "There has been a lot of violation of human rights, there is a need to pay attention towards this." It should be reflected in action and Judicial Council will be launching few more programme for protecting human rights.
