				them from using designs of Plaintiffs and also compensation of Rs.2,00,00,000/- as damages. Subsequently, the Parties have entered into a Joint Memorandum wherein Plaintiffs have agreed to withdraw the suit and also waive all the reliefs including the relief of damages. Accordingly, Hon'ble High Court of Madras decreed the suit in terms of the Joint Memorandum.
