This has reference to Letters bearing ref.nos. Orient/Stock Exch/Letter/261 dated 9th June, 2021 and Orient/Stock Exch/Letter/264 dated 2nd July, 2021 and various updation vide Financial Results filed since then with stock exchange through which the Company from time to time has updated about the status of operations at the Plant of the Company situated at Porbandar, which was affected due to non-availability of the specialized grade Bauxite.

In this connection, we would like to inform that the Hon'ble Industrial Tribunal, Jamnagar, has vide its order dated 15th September, 2022, which the Company received on 20th September, 2022, approved the application filed by the Company for closing down the institution / unit since 30-09-2021 for want of availability of aforementioned raw material, which was utilised for production of brown fused alumina and calcined bauxite.

However, the order does not affect the other running units which produce non-bauxite based products at the same location.
