2. In compliance with all the applicable provisions of the Companies Act, 2013 and rules made thereunder and the Securities and Exchange Board of India ("SEBI") (Listing Obligations and Disclosures Requirements) Regulations, 2015, read with General Circular No. 14/2020 dated April 08, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No. 20/2022 dated May 05, 2020, General Circular No. 02/2021 dated January 13, 2021 and General Circular No. 03/2022 dated May 05, 2022 (collectively referred to as "MCA Circulars") and Circular No. SEBI/HO/CFD/CMD1/ CIR/P/2020/79 dated May 12, 2020, circular No. SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated January 15, 2021 and Circular No. SEBI/HO/CFD/CMD2/CIR/P/2022/62 dated May 13, 2022 other applicable circulars issued by the Ministry of Corporate Affairs ("MCA") and SEBI and in furtherance of Go Green Initiative of Govt., the Company has e-mailed the Notice of the 38th AGM along with the Annual Report for the FY 2021-22 on Thursday, 25th August, 2022 through electronic mode only, to those members whose e-mail addresses are registered with the Company/ Registrar & Transfer Agent or Depository Participant. The requirement of sending physical copies of the Notice of AGM and Annual Report has been dispensed vide aforesaid circulars.

3. The Annual Report for the FY 2021-22 and the Notice of the 38th AGM has also been available on the website of the Company www.hitechpipes.in, on the website of Stock Exchange(s) i.e. National Stock Exchange of India Limited www.nseindia.com, BSE Limited www.bseindia.com and also on the website of National Securities Depository Limited ("NSDL") (www.evoting.nsdl.com).

4. The Final Dividend of Rs. 0.50/- per equity share for the FY 2021-22, was recommended by the Board of Directors in their meeting held on May 14, 2022 for the approval by Shareholders at 38th AGM. The Board has fixed **September 21, 2022 as "Record Date"** for determining entitlement of the members to final dividend for FY 2021-22. The Dividend, if declared at the 38th Annual General Meeting, will be paid within 30 days from the date of AGM i.e. September 28, 2022, to the Members who have updated their bank account details with the Depositories for the shares held in Demat mode. For Members, who have not updated the bank account details, dividend warrants/demand drafts/cheques will be sent to the registered addresses by permitted mode.

Instructions for remote e-voting and e-voting during the AGM:

5. In compliance to the provisions of Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, the Secretarial Standard on General Meeting (SS-2) issued by the Institute of Company Secretaries of India and Regulation 44 of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 as amended from time to time, the Company is providing the members the facility to exercise their right to vote at the 38th AGM by electronic means only before the AGM and during the proceedings of the AGM in respect of the businesses to be transacted at the AGM and for this purpose the Company has availed the **e-voting services of National Securities Depository Limited (NSDL)**.

6. Notice is also given that pursuant to the Section 91 of the Companies Act, 2013 ("The Act") and the rules framed thereunder, as amended from time to time, the Register of Members and the Share Transfer Books of the Company shall remain closed from **Thursday, 22nd September, 2022 to Wednesday, 28th September, 2022** (both days inclusive) for the purpose of AGM.

7. The detailed instructions for the e-voting are given in the Notice of the AGM, Members are requested to note the following:

- The **Remote e-voting** shall be commencing on **Sunday, 25th September, 2022 from 9:00 a.m.** and shall end on **Tuesday, 27th September, 2022 at 5:00 p.m.** The e-voting module shall be disabled by NSDL for the voting thereafter and Members will not be allowed to vote electronically beyond the said date and time.
- The voting rights of the Members (for remote e-voting or voting during the AGM) shall be in proportion to their share of the paid-up equity share capital of the company as on **Wednesday, 21st September, 2022 ("Cut-Off Date")**. A person whose name is recorded in the Register of members or in the Register of Beneficial Owner maintained with the Depository as on the Cut-Off date only shall be entitled to avail the facility of remote e-voting as well as the voting during the AGM.
