Subject: Updates on Investments

In continuation to our letter dated May 29, 2022 in respect to outcome of Board meeting, we further inform you that based on the recommendation of Audit Committee, Board at their meeting also considered and approved the following updates on Investments:

- a) Extension of time period of proposal of incorporation of Wholly Owned Subsidiary in Hyderabad from June 30, 2022 to March 31, 2022. The said proposal was approved by the Audit Committee and Board of Directors of the Company in their earlier meeting held on November 12, 2021 and which was subsequently informed to the stock exchange on November 13, 2021.
- b) Due to resignation of Mr. Soumyadri Bose from the Directorship of the Company, the proposal of investment to be made in securities GOFX Platform Technologies Pte. Ltd (GPTPL) as approved by the Audit and Board in their meeting held on August 14, 2021, is cancelled, as GPTPL is a wholly owned subsidiary of GOFAR Advisory and Investments Pte Ltd. (GAIPL) wherein Mr. Soumyadri Bose hold substantial stake and directorship and directly/indirectly control and/or participate in the business operation of GPTPL. The said investment proposal was informed to the Stock Exchange on August 14, 2021.
