DoT trying to get more spectrum in mid-bands for auction

PRESS TRUST OF INDIA New Delhi, October 16

THE DEPARTMENT OF telecommunications (DoT) is trying to get more spectrum in the 3.3-3.6 GHz band for 5G services, a top official said on Wednesday.

The industry has raised concerns over the limited availability of spectrum in the mid-frequency bands marked for 5G services.

With the defence and the space departments claiming frequencies in the 3.3-3.6 GHz band, which has been recommended for 5G services by regulator Trai, around 175 MHz of radio waves have been left free for mobile services.

"We are trying to get more spectrum in medium bands of 3.5 GHz and for 5G. Sub- 1 GHz band like 700 MHz can also be used for 5G," telecom secretary Anshu Prakash told PTI on the sidelines of the India Mobile Congress event here.
