Therefore, the net result (i.e. revenue less expenses) of these discontinued operations have been disclosed separately under 'Discontinuing Operations' as per the requirements of Ind AS 105. Further, during the quarter NYJL has transferred its contractual obligations (including placement, collection and closure responsibility) and all assets & liabilities to the Company for completion of continuing commitments. This transaction has been treated as business combination and the Company has applied pooling of interest method to account for such Business Combination. Based on the requirements of Appendix C to Ind AS 103, the Company has restated financial information appearing in these financial results in respect of previous periods as if the merger had occurred from the beginning of the preceding period in the financial statements i.e. April 1, 2018, irrespective of the date of the transaction. Accordingly profit for the three months period ended September 30, 2019, December 31, 2018, year to date period ended December 31, 2018 and year ended March 31, 2019 has increased / decreased by ₹. 175.79 Million, ₹. (23.24) Million, ₹. (60.55) Million and ₹. 90.42 Million respectively.
