EXTRACTS FROM THE PROCEEDINGS OF THE 229TH MEETING OF THE BOARD OF DIRECTORS OF INDIA NIPPON ELECTRICALS LIMITED HELD AT 10:00 AM ON THURSDAY THE 10TH AUGUST 2023 AT THE REGISTERED OFFICE OF THE COMPANY LOCATED AT NO.11 & 13 PATULLOS ROAD, CHENNAI-600002. TEL (44) 28460063.

Re-classifying the promoter shareholders pursuant to Regulation 31A of SEBI Listing Regulations, 2015.

Consequent upon the acquisition of shares by Lucas Indian Service Limited (LIS) on 26th June 2023 from the other promoter entities viz., 14,14,786 equity shares from Mahle Electric Drives Japan Corporation (MEDJ) and 30,00,000 equity shares from Mahle Holding India Private Ltd (MHIPL) vide Share Purchase Agreement dated 19th June 2023 and termination of the Joint Venture agreement vide Termination Agreement dated 17th July 2023, the shareholding of both MEDJ and MHIPL became 'NIL' and the shareholding of LIS became 70.32%.

Following this, Mr Jakob Ruemmler (DIN: 09237428) and Mr Kiyoyasu Kawakami, (DIN: 09283649), Directors tendered their resignation from the directorship of INEL effective from the closing hours of 19th July 2023 and the same has been intimated to the Stock Exchanges on 19th July 2023 and necessary form(s) filed with the Registrar of Companies, Ministry of Corporate Affairs, Government of India.

Considering the above, the Board has taken the above resignations on record and placed on record its appreciation of the services rendered by Mr Jakob Ruemmler and Mr Kiyoyasu Kawakami during their tenure as Directors of the Company.

The Board of Directors perused the request letters dated 7th August 2023 received from MEDJ and MHIPL for reclassification from the Promoters category to public category and accepted and approved the same on the basis of the rationale and the confirmation provided by the outgoing Promoters in accordance with provisions of Regulation 31A of the SEBI (LODR) Regulations, 2015. Further, the Board noted that the respective request letters were forwarded by the company to the Stock Exchanges.

Further, the Board was also briefed that the Outgoing Promoters has specifically mentioned in their respective requests that they are satisfying all the conditions specified in sub clause (i) to (vii) of clause (b) of sub regulation 3 of Regulation 31A of SEBI (LODR) Regulations, 2015.

The Board further noted that the promoter(s) seeking reclassification, together hold Nil Shares. Since they do not have any shares/voting rights in the listed entity, approval of the shareholders pursuant to Regulation 31A(3)(a)(iii) of SEBI(LODR) Regulations, 2015 is not required.
