Hamirpur assembly bypoll: **EC** experiments with QR code enabled voter slips in 5 booths

Hamirpur .The Election Commission of India (ECI) has launched a pilot project in which it is using Quick Response (QR) enabled voter slips during polling. At present, five booths in Uttar Pradesh's Hamirpur are using the QR code enabled slips. Voting for the Hamirpur assembly segment by election is currently underway.

The slips can be scanned with a mobile phone, even without the internet, which makes it even more user-friendly as many in the interiors of the country do not use, or have access to an internet connection.

By scanning the code, voters can get details about their booths, such as the number of people in the queue, the per centage of voting done, among others.

Five booths in Hamirpur, including three in the rural areas, are using the QR-code enabled slips. The QR code enabled slips will also save time during polling. On reaching the polling station, the booth-level officer present there will scan the slip from his mobile and send it directly to the presiding officer. After this, the presiding officer will also scan the code and send the voter to the EVM to cast his vote it.

Man uploads video on TikTok, threatens to commit suicide from hotel rooftop in Delhi

New Delhi. Aman threatened to commit suicide from a rooftop of a hotel in Delhi's Hari Nagar area on Sunday.Sandeep alias Armaan Malik climbed onto the rooftop of a hotel building and put up a video on TikTok threatening to commit suicide.

The video went viral and within hours of uploading the video, Armaan Malik's followers increased significantly.

Armaan is very famous on TikTok and has about 50 lakh followers. He uploaded three videos of suicide threats.

In one of the videos, Armaan said, "My wife Payal and her family members together framed me in a rape case." In another video, Arman mentions his maid and someone named Neeraj. In the third video, Armaan uploaded a letter of suicide threat on his TikTok account. Armaan in his letter blamed Payal and her sisters behind this move. According to the information, Payal is Armaan's first wife and he got married in the same hotel from where he was attempting to commit suicide. According to the police, Armaan cae to this hotel from Ahmedabad with his second wife and suddenly something happened between the two following which Armaan went to the

Managing Director of Simbhaoli Sugar Mill, Gursimran Kaur, were among the five company officials named in the FIR under sections of the Indian Penal Code along with sections of the Essential Commodities Act.In the complaint, farmers alleged that they should get 85 per cent of the amount collected by the sugar mill from selling sugar but they were not given the same.
