In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulation 2015, we would like to inform you that because of the severe nature of the current global COVID-19 (coronavirus) pandemic and in compliance with the government directives, the Company has temporarily closed down its factories at Pune and Puducherry from Monday 23rd March, 2020, until further notice.

In this regard, the Company has advised its employees to follow 'Work from Home' policy until further directions. Though the security personnel and the employees working in the information technology department have been advised to closely monitor the situation at the plants, while maintaining safe distance amongst themselves and avoid any gathering.

It may kindly be noted that during these unforeseen and unprecedented times, the Company's sales and profitability will get impacted until such time the factories remain shut. It is difficult to quantify the same in financial terms.

We will keep the Stock Exchanges informed as and when any significant developments will be noted. The delay in this submission may please be condoned considering the unusual situation that we have been put into.
