**Sub: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

Dear Sir/Madam,

These disclosures are made pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015:

- A. The State Tax Officer, Chennai vide its order dated 25<sup>th</sup> April 2024 has levied a penalty of Rs. 109,680/- under Section 73 of the Central Goods and Service Tax Act, 2017 on Trident Chennai, one of the hotels of the Company. The penalty is related to ineligible Input Tax Credit (ITC) on Works Contract for the Financial Year 2018-19.

The copy of said order was received order on 25<sup>th</sup> April 2024 at 06.10 P.M. The financial impact of the aforesaid order is to the extent of the penalty imposed.

- B. The Joint Commissioner (State Tax), Jaipur vide its order dated 25<sup>th</sup> April 2024 has levied a penalty of Rs. 99,691/- under Section 73 of the Central Goods and Service Tax Act, 2017 on The Oberoi Rajvilas, one of the hotels of the Company. The penalty is related to Input Tax Credit (ITC) claimed from cancelled dealers, return defaulters & non-taxpayers for the Financial Year 2018-19.

The copy of said order was received order on 25<sup>th</sup> April 2024 at 07.25 P.M. The financial impact of the aforesaid order is to the extent of the penalty imposed.
