एसपीवाई एग्री के प्रबंध निदेशक एस श्रीधर रेड्डी ने बताया कि उच्च दबाव के चलते एक वाल्व में विस्फोट हुआ लेकिन कोई गैस लीक नहीं हुई।

चीन को सैन्य आक्रामकता की भारी कीमत चुकानी होगी : विशेषज्ञ

नई दिल्ली, 27 जून (भाषा)।

रणनीतिक मामलों के विशेषज्ञों ने शनिवार को कहा कि पूर्वी लद्दाख में भारत के प्रति आक्रामक सैन्य रवैया अपनाने के लिए चीन को दशकों तक भारी कीमत चुकानी पड़ेगी क्योंकि इससे वह देश वैश्विक स्तर पर अलग-थलग पड़ जाएगा। उन्होंने कहा कि पूर्वी लद्दाख और दक्षिण चीन में पिछले कुछ महीनों में चीन के दुस्साहस की उसे व्यापक स्तर पर आर्थिक कीमत चुकानी होगी। इसने बेजिंग के 'असली चेहरे' को इस समय बेनकाब किया है, जब पूरी दुनिया कोरोना विषाणु से लड़ रही है।

विशेषज्ञों ने अमेरिका के साथ चीन के 'टैरिफ वॉर' और व्यापार से जुड़े मुद्दों पर ऑस्ट्रेलिया के साथ बढ़ती तकरार और हांगकांग में तेजी से बिगड़ती स्थिति का भी जिक्र किया। सेना के पूर्व उपप्रमुख लेफ्टिनेंट जनरल गुरमीत सिंह ने कहा कि चीन ने पूर्वी लद्दाख में आक्रामक सैन्य रवैया अपनाकर एक बड़ी गलती की है। यह गतिरोध तब शुरू हुआ जब पूरा विश्व कोरोना महामारी से लड़ रहा है। चीन ने खुद को

वैश्विक स्तर पर बेनकाब कर दिया है।

उन्होंने कहा कि चीन को यह काफी महंगा पड़ेगा। गलवान घाटी में 15 जून को हिंसक झड़प में भारतीय सैनिकों के मारे जाने की उसे दशकों तक कीमत चुकानी होगी। चीन ने भारत और अन्य स्थानों पर अपनी साख को खो दिया है। गलवान घाटी में भारतीय सैनिकों पर हमले का जिक्र करते हुए उन्होंने कहा कि इस कार्रवाई ने इस दृष्टिकोण को मजबूत किया है कि चीन की पीपुल्स लिबरेशन आर्मी 'सिर्फ एक राजनीतिक' बल है और यह सैन्य मानकों के अनुरूप नहीं है। सेना के पूर्व उपप्रमुख लेफ्टिनेंट जनरल सुब्रत साहा ने कहा कि चीन ने अपनी अस्वीकार्य सैन्य आक्रामकता से खुद को अलग-थलग कर लिया है और इसके लिए इस देश को भारी कूटनीतिक और आर्थिक कीमत चुकानी होगी। उन्होंने कहा कि चीन ने इस आक्रामकता से खुद को सैन्य और कूटनीतिक स्तर पर अलग-थलग कर लिया है और इसकी उसे कीमत चुकानी होगी। उन्होंने हांगकांग, दक्षिण चीन सागर के साथ-साथ पूर्वी चीन सागर को लेकर बढ़ती अंतरराष्ट्रीय चिंताओं का भी जिक्र किया।

शिक्षकों की शिकायत, डिजिटल कक्षाओं में शामिल नहीं हो रहे ज्यादा बच्चे

पुणे, 27 जून (भाषा)।

गोवा में ऑनलाइन कक्षा अनिवार्य नहीं होने की मुख्यमंत्री प्रमोद सावंत की घोषणा के कुछ दिन बाद उच्च माध्यमिक विद्यालयों के शिक्षकों ने शिकायत की है कि अनेक विद्यार्थी डिजिटल कक्षाओं में शामिल नहीं हो रहे हैं। इसी सप्ताह के प्रारंभ में सावंत ने स्पष्ट किया था कि ऑनलाइन कक्षाएं अनिवार्य नहीं हैं क्योंकि कई विद्यार्थियों के पास जरूरी उपकरण या उपयुक्त इंटरनेट सुविधाएं नहीं हैं।

उच्च माध्यमिक शिक्षक संघ ने एक विज्ञापित में सवाल उठाया कि राज्य सरकार ने ग्यारहवीं और बारहवीं कक्षाओं के लिए विद्यालयों से ऑनलाइन कक्षाएं शुरू करने को कहा ही क्यों था? संघ के अध्यक्ष अनंत पिरसुलेकर ने कहा कि पहले मुख्यमंत्री ने कहा था कि कोविड-19 महामारी के चलते विद्यालयों के खुलने में देर होगी। उसके अनुसार, शिक्षा विभाग ने शिक्षकों को ऑनलाइन कक्षाओं का प्रशिक्षण दिया। उन्होंने दावा किया कि शिक्षकों की हाल की घोषणा से ऑनलाइन कक्षाओं से जुड़े रहे विद्यार्थियों की संख्या में कमी आई है, पहले जो विद्यार्थी कक्षाओं में आ रहे थे, वे अब नहीं आ रहे हैं। पिरसुलेकर ने सवाल किया, 'यदि ये ऑनलाइन कक्षाएं लाभप्रद नहीं हैं तो उन्होंने इन्हें शुरू करने को कहा ही क्यों था?'
