I, Shalini Jain, Practicing Company Secretary (Membership No. 50348 / C.P No. 19190), have been appointed as the Scrutinizer by the Board of Directors of Cian Healthcare Limited pursuant to Section 108 of the Companies Act, 2013 (the "Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (MGT Rules), as amended and Regulation 44 of SEBI (Listing Obligation and Disclosure Requirement) Regulations, 2015, (Listing Regulation) to conduct the remote e- voting process and voting at EGM through ballot paper in respect of the businesses contained in Notice of 02nd Extra-Ordinary General Meeting ("EGM") for the financial year 2021-22 of Cian Healthcare Limited.
