Indian Navy's P-8I maritime patrol aircraft taking part in anti-submarine warfare exercise

New Delhi The Indian Navy's P-8I maritime patrol aircraft taking part in a multilateral anti-submarine warfare exercise Sea Dragon-2021 in Guam. Along with India, America, Japan, Canada and Australia are taking part in the drills which would involve tracking submarines.

Sea Dragon 2021, centers on anti-submarine warfare (ASW) training and excellence to include 125 hours of in-flight training ranging from tracking simulated targets to the final problem of finding and tracking USS Chicago (SSN 721), a U.S. Navy Los Angeles-class nuclear submarine. During classroom training sessions, pilots and flight officers from all countries will build plans and discuss incorporating tactics, capabilities and equipment for their respective nations into the exercise. Each exercise is graded, and the nation scoring the highest total points will receive the coveted Dragon Belt award. The belt was formally introduced last year when awarded to the Royal New Zealand Air Force (RNZAF).

Names of Galwan braves put up at National War Memorial ahead of Republic Day

New Delhi After a delay of months, the names of Galwan braves who were killed in action amid the military tussle with China in Ladakh have finally made it to the National War Memorial in New Delhi ahead of Republic Day.

Earlier, names of 90 soldiers killed in various operations between October 2019 and September 2020 were cleared for being inscribed at the National War Memorial that was unveiled in February 2019.

Though the names were cleared, further procedural delays meant the names could not be put up before.

If the matter was not hurried, the names would have been missing during Republic Day when Prime Minister pays homage to the fallen soldiers at the National War Memorial. Since last year, tributes are paid to those who sacrificed their lives in military action at the new memorial on Republic Day instead of India Gate. The National War Memorial was built in memory of those who were killed in action after Indian independence. In the Galwan clash of June 15, 2020, India lost 20 soldiers in an area called the Galwan Valley in a fierce hand-to-hand combat with the Chinese soldiers. China, however, never revealed the number of casualties on its side. India and China standoff has now entered its ninth month as both sides continue with heavy deployment of troops, artillery guns, tanks and armoured vehicles in close proximity. The tensions started with skirmishes along Pangong Lake in May when troops came to blows on more than one occasion leaving many injured on both sides.

"This Is Tejjashwi Yadav Speaking". A Phone Call In Bihar Goes Viral

New Delhi: Bihar opposition leader Tejjashwi Yadav failed to oust Chief Minister Nitish Kumar in the November state election but his clout is intact, or so it appeared from his phone chat with a top official, widely shared on social media.

The Rashtriya Janata Dal (RJD) leader arrived to show his support to protesting teachers in Patna when he was told that the protesters had been denied permission for a sit-in at their planned venue. He spoke to the Chief Secretary, police chief and the Patna District Magistrate and extracted an assurance that the protest would be allowed.

In a video that is in circulation online, Tejjashwi Yadav is seen speaking to Patna District Magistrate Chandrashekhar Singh on the spot, surrounded by the protesting teachers. Mr Singh can be heard on speaker phone. "These people say they are not being allowed to sit on dharna," Tejjashwi Yadav said, and asked why. "Will they need to keep asking for permission daily? There has been a lathi charge, their food has been thrown away, they were driven away... Now they are all scattered. Some of them are here at Eco Park with me..." The RJD MLA said the teachers only wanted to exercise their democratic right to protest.

"Whatsapp kara dete hai inka application (I will send you their application by WhatsApp. You please allow them," he "instructed" the senior official. The officer, rattled by this time, shot back: "Kab tak meaning? You will question me?"

The RJD leader replied evenly: "Hum Tejjashwi Yadav bol rahein hai, DM sahab (This is Tejjashwi Yadav speaking)." A pause, then an instant change of tone. "Achha sir, sir, sir (Ok, sir)," Mr Singh said, as the protesters burst into laughter. "I will send you a WhatsApp test. Respond fast or we will have to sit here all night," Tejjashwi Yadav said, cutting the call. Sharing the clip, activist Sudheendra Kulkarni, a former aide of former Prime Minister Atal Bihari Vajpayee, commented: "Must watch. And watch it till the end to know why Tejjashwi Yadav is fast emerging as one of the most promising mass leaders of India."
