Surat Crime Branch moves court against bail to suspended BJP leader, his aides

THE SURAT CRIME Branch on Monday filed an application for the cancellation of bail of a suspended BJP leader and his two aides amid a probe into the attempts of defaming the party and the BJP's Gujarat president C R Paatil. The Surat District Court is set to hear the matter on Tuesday.

The cops have approached the court to seek the cancellation of bail for Solanki and his two aides - Khumansinh Patel and Dipu alias Sonu Yadav. The complaint against the three was filed by Choryasi MLA Sandeep Desai on August 2 over their alleged role in defaming Paatil and the party. Acting on the complaint, police arrested the trio the same day under IPC sections 469, 500, 501, 120(b). They were released on bail on August 3.

Solanki and his two aides recorded their statements last week with the Surat Crime Branch, people aware of the developments said.

"There was a signature of a BJP councillor from Ward 1 of SMC, Rajendra Patel, at the bottom of the letter alleged to be defamatory, which Solanki and his aides had allegedly prepared and sent to Sandeep Desai and other BJP MLA. We called Rajendra Patel and questioned him about the signature. He denied the claims, and later we made him sign on a paper to take a sample of his signature. We talked both signatures and found them to be different. When questioned, the three suspects broke down and confessed to having forged the signature of BJP Councillor Patel," an official said on conditions of anonymity.

The Crime Branch filed an application with the Surat District Court for the addition of IPC sections 467 (forgery of valuable security, will), and 468 (forgery for purpose of cheating), on Friday in the complaint of Sandeep Desai. The court had on Monday allowed the addition of sections.

An official with the Surat Crime Branch, pleading anonymity, said, "Once we get the application for cancellation of bail approved from the Surat District Court, we will again arrest Rakeshsinh Solanki, Dipu alias Sonu Yadav and Khumansinh Patel. We have got a few more leads into the case."

On Saturday, the BJP suspended Rakeshsinh Sokanki along with two other party leaders Devendrasinh Chauhan, and Hardeepsinh Atodaria, for alleged anti-party activities and tarnishing the image of the party.

Ready to admit students from Manipur whose education was hit: Kerala varsity

The University of Kannur in Kerala has decided to open its doors for students from Manipur who could not continue their education due to the violence in their home state.

The decision was taken at a meeting of the university syndicate after taking into consideration pleas from various students' organisations in Manipur.

Vice-chancellor Dr Gopinath Ravindran said the university was ready to admit students from Manipur in both undergraduate and postgraduate courses.

The V-C added admission would be arranged in university departments as well as in affiliated colleges, depending upon the requirements of the students. "The university will also provide accommodation for the students. [They] will be given the required time to furnish documents related to their eligibility," he said. A student from Manipur has already shown interest in joining a Masters in Physical Education and Sports course in the Physical Education Department, the V-C said.

Court rejects pleas of Kejriwal, Sanjay Singh for interim stay on trial in PM Modi degree row

A SESSIONS COURT in Ahmedabad rejected applications moved by Delhi Chief Minister Arvind Kejriwal and Aam Aadmi Party (AAP) Rajya Sabha member Sanjay Singh for an interim stay on trial against them in a criminal defamation case. The court of sessions judge AJ Kanani rejected the pleas of the AAP leaders for interim stay on trial by the metropolitan court in a criminal defamation case filed by Gujarat University over their "sarcastic" and "derogatory" statements in connection with Prime Minister Narendra Modi's degree.

The court passed its order Saturday and kept the matter for next hearing on August 21, after respondent Gujarat University sought time, their lawyer Punit Juneja said on Monday.

Kejriwal and Singh had filed a revision application in the sessions court challenging the metropolitan court's summons in the defamation case and had sought interim relief from the sessions court during the pendency of their main application, which was rejected by the court, Juneja said.

The metropolitan court has directed the two leaders to remain present in the court on August 11 in response to summons issued to them in this connection.

The court refused to grant them interim relief in the matter on the ground that the two leaders had told the metropolitan court that they will remain present before it on August 11. Juneja said they will seek relief before the Gujarat High Court.

The metropolitan court has summoned the two leaders after observing that prima facie there appeared to be a case against them under section 500 of the Indian Penal Code (IPC).

Gujarat University Registrar Piyush Patel had filed a defamation case against Kejriwal and Singh over their comments after the Gujarat High Court set aside an order of the Chief Information Commissioner on PM Modi's degree.

They made "defamatory" statements in press conferences and on Twitter handles targeting the university over Modi's degree, the complainant stated. Their comments targeting Gujarat University were defamatory and hurt the prestige of the university which has established its name among the public, as per the complainant.

Their statements were sarcastic and intended to intentionally hurt the prestige of the university, he said.

The statements by the two Aam Aadmi Party leaders would make a person believe that the Gujarat University issues fake and bogus degrees, the complainant further stated.

Two marijuana plants found near GU boys hostel; NSUI, ABVP demand action

THE NATIONAL STUDENTS' Union of India (NSUI) on Monday complained to police about the presence of marijuana plants near the boys' hostel of Gujarat University. Following the complaint, Akhil Bhartiya Vidyarthi Parishad (ABVP), the BJP-affiliated student wing, also sought action and security on the campus.

"We received the information at around 4 pm, and found out that there are two marijuana plants. We immediately called the FSL team and did the panchama. We confiscated the plants and sent them out for testing," said Viraj Jadedja, police inspector of Gujarat University Police Station. "NSUI got the information about the presence of marijuana plants behind the Gujarat University D Block boys hostel and the issue was brought before the

police authorities and the negligence of the warden and security system of the Gujarat University hostel was exposed. Samples of plants were taken to verify these to be marijuana, and if this is confirmed, strict action against the management should be taken. Eight days ago, marijuana plants were found from Rajkot's Marwadi University," Subhan Saiyed, spokesperson, Gujarat State Youth Congress, told The Indian Express. Later in the night, the ABVP too issued a statement, condemning the plantation of marijuana on the university campus as a 'shame' and asking the authorities to ensure security of the campus. "Plantation of marijuana plants on a university campus is a shame. Gujarat University administration should ensure campus security. Due to the lax policy of the university authorities, Gujarat University, the largest university in the state, has become a center of controversies and not

careers. Cannabis plants have been found in D Block Hostel of the university campus. Drug addiction cannot be given any place in Gandhiji's Gujarat. The hostel of Gujarat University has become a shelter for anti-social elements. Many students who are not studying at Gujarat University are staying in various hostels of the university and joining in anti-social activities," ABVP stated in a statement. ABVP's Ahmedabad city secretary Umang Mojindra stated, "The university should conduct a search operation in the hostel of Gujarat University and remove the anti-social elements living illegally and file a police complaint against them for unauthorised entry. Besides, the university should issue an explanatory notice to the security agency and take legal action on the university campus. ABVP has clearly demanded strict action against those elements who disturb the atmosphere of the university campus by moni-

toring it with CCTV cameras. Gujarat University continues to be an unsafe campus. Videos of luxury car stunts have gone viral as the university campus has become a racing track." However, the authorities ensured that action will be taken against students who are involved in this. When contacted, chief warden Amrut Bharwad told The Indian Express, "Though I was out throughout the day, I was informed via phone about the presence of the plantation in the open ground. We will investigate this and action will be taken against whoever student is involved in this. Also, there is a lot of vegetation around the hostels during the monsoon season which we usually get cleared but this year could not, which I accept." "We are waiting for FSL report to understand details like how big the plants were or for how much time were they planted," the police inspector added.
