Madam / Sir,

With reference to the above mentioned reference and pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015 as amended, we wish to inform you that the Committee of Directors for Raising Capital Funds ("Committee") has at its meeting held today i.e. February 20, 2024, inter alia:

- a. Approved the raising of funds for an amount not exceeding ₹ 3000 Crore through issue of equity shares through Qualified Institutions Placement subject to the requisite regulatory /statutory approvals, as applicable.
- Approved and adopted the Preliminary Placement Document dated February 20, 2024 and the application form dated February 20, 2024 in connection with the Issue ("Preliminary Placement Document");
- c. Approved the Floor Price of ₹ 142.78 per equity share for the Issue;
- d. Approved the opening of the Issue today, i.e. February 20, 2024; and

We further wish to inform you that the 'Relevant Date' for the purpose of the Issue, in terms of the Regulation 171(b)(i) of the SEBI ICDR Regulations, is February 20, 2024 and accordingly the Floor Price in respect of the aforesaid Issue, based on the pricing formula as prescribed under Regulation 176(1) of the SEBI ICDR Regulations is ₹ 142.78 per Equity Share. Pursuant to the SEBI ICDR Regulations, the Bank may offer a discount of not more than 5% on the Floor Price so calculated for the Issue.

The meeting of the Committee commenced at 4:30 P.M. and concluded at 5:20 P.M.
