Gangster Goldy Brar mastermind behind murder of Moosewala: Punjab Police chargesheet the news of withdrawal of security of Moosewala to shooters on May 28 and had asked them to hurry up and kill the singer on May 29, according to chargesheet. Moosewala was among the 424 people whose security was pruned by the Punjab Police on temporary basis.

Shubhdeep Singh Sidhu, popularly known as Sidhu Moosewala, was shot dead in Punjab's Mansa district on May 29. He was killed when he, along with his friend and coustin, was travelling in a jeep to Jawahar Ke village in Mansa. Six shooters wayladi and sprayed bullets on hin.
