This is with reference to letter dated August 10, 2023 informing to Stock Exchange that the entire share capital of Ichikoh (Wuxi) Automotive Parts Co., Ltd, China (“IWAP”), now name changed to Wuxi SMR Automotive Parts Co., Ltd., a step down wholly owned subsidiary through Samvardhana MotherSON Automotive Systems Group BV, Netherlands (“SMRP BV”) will be divested to Ningbo SMR Huaxiang Automotive Mirrors Co. Ltd., China (“SMR NBHX”). SMR NBHX is a 50:50 joint venture between Ningbo Huaxiang Electronics Co. Ltd. (“NBHX”) and Company (through one of its subsidiary in SMRP BV).

In this respect, it is respectfully submitted that the share capital transfer of IWAP to SMR NBHX has completed on October 19, 2023 and release of purchase consideration by SMR NBHX is expected to be completed by November 30, 2023.
