

Gist of proceedings of the 25th Annual General Meeting of Network18 Media & Investments Limited

A. Date, time and venue of the Annual General Meeting :

The 25th Annual General Meeting of the Company was held on Monday, September 21, 2020 through Video Conferencing (“VC”) (“the Meeting”). The Meeting commenced at 12:00 Noon (IST) and concluded at 12:58 p.m. (IST).

B. Proceedings in brief:

- Mr. Adil Zainulbhai, Chairman and Independent Director, chaired the Meeting.
- The requisite quorum being present, the Chairman called the Meeting to order.
- The Chairman informed that the Meeting was held through VC in compliance with the circulars issued by the Ministry of Corporate Affairs, Government of India and Securities and Exchange Board of India.
- The Chairman addressed the members.
- The Chairman informed that remote e-voting commenced at 9:00 a.m. on Thursday, September 17, 2020 and concluded at 5:00 p.m. on Sunday, September 20, 2020.

3. Appointment of Ms. Bhama Krishnamurthy as an Independent Director.
 4. Ratification of the remuneration of Cost Auditor, for the financial year ending March 31, 2021.


C. Voting by Members
