THE TRANCHE II ISSUE IS BEING MADE PURSUANT TO THE PROVISIONS OF SECURITIES AND EXCHANGE BOARD OF INDIA (ISSUE AND LISTING OF NON-CONVERTIBLE SECURITIES) REGULATIONS, 2021 (THE "SEBI NCS REGULATIONS"), THE COMPANIES ACT, 2013 AND RULES MADE THEREUNDER, AS AMENDED AND TO THE EXTENT NOTIFIED.

This is with respect to Tranche II Issue of NCD by Indiabulls Housing Finance Limited which opened for subscription from Wednesday, September 06, 2023 and closed on Wednesday, September 20, 2023. The allotment of NCDs took place on September 26, 2023 and the listing notice dated September 27, 2023 was issued by BSE Limited ("**BSE**") and National Stock Exchange of India Limited ("**NSE**") together referred to as Stock Exchanges, admitting the NCDs to dealings on the Stock Exchanges with effect from Thursday September 28, 2023.

Pursuant to the Tranche II Issue, we would like to bring to your kind notice that inadvertently there has been an error in nine ISINs, as per detailed mentioned below, while updating the ISIN by Kfin Technologies Limited, the Registrar to the Issue during the Corporate Action Process against the valid applicants.
