Particularly, the Earlier Disclosure was made (a) since certain conditions under the Agreements were likely to fall within the definition of encumbrance under the Takeover Regulations and (b) Dipika Amar Vakil had pledged 21 lakh, 21 lakh & 38 lakh shares of Asian Paints Limited ("APL") in favour of ABFL, IFPL and TCFSL, respectively on 19/03/2022.

ABFL has released the pledge over 21 lakh shares of APL on 16/06/2022. However, the conditions under the Agreements with ABFL continue to apply as they have not been terminated as yet.
