■ This live-action animated film based on the iconic cartoon series follows Tom and Jerry as they leave their homes and move to New York to start afresh.

Jerry takes up a tiny spot at the prestigious Royal Gate Hotel in New York City and begins to create havoc. No reputed hotel wants a rodent around, but when new employee Kayla (Chloe Grace Moretz) is tasked with getting rid of the little fellow, she finds herself outwitted. Amidst this mouse problem, the grand wedding of Preeta (Pallavi Sharda) and Ben (Colin Jost) needs to be planned and executed. There's pressure on the hotel staff and owner Mr. DuBross (Rob Delaney) along with deputy Terrance (Michael Pena) certainly add to that. So, when Kayla comes

across Tom, she enrolls him to help her with Jerry. For the 80s and 90s kids, the beloved cartoon series invokes a strong sense of nostalgia. Director Tim Story captures that classic feel in this live-action animated film, by featuring the animated characters as modernised renditions of the 2D cartoons. It does a massive favour because it immediately takes you back, thanks to the animators. The toons' whole appeal was the creative ways these frenemies would go at each other, resulting in slapstick at its best. This film's broad story line tries to flesh out some of the human characters. Moretz is generally likeable, and her charm is on full display as Kayla, the new employee trying to impress her bosses. Michael Pena brings his distinctive style to Terrance, a stickler for his distinguished property's old school values. Colin Jost and Pallavi Sharda both channelise influencer couple cheesiness as Ben and Preeta, though there's more going on there. The real heroes are, of course, Tom and Jerry who never miss an opportunity to get into their classic spats, and yet, somehow still manage to look out for each other in their own ways.

■ Sue Butters (Allison Janney) decides to spin her missing husband's story, but it goes a bit too far.

Sue is a suburban wife who lives in obscurity. She is a pushover; to the extent that both her husband Karl (Matthew Modine) and sister Nancy (Milla Kunis) forget her birthday. So, when her husband files, Sue decides to get her 15 minutes of fame with local news personality Gloria Michaels (Juliette Lewis). However, she doesn't realise that Karl has been up to no good and some goons like Mina (Awkwafina) are out to get him. Soon enough, the yarn spins out of her control and Sue finds herself in over her head. Equipped with many talented performers, the plot sprints straight out of a Coen brothers' film.

Sady, it's quite a narrative mess, because the characters are not fleshed out well enough. Very few of them have any redeeming qualities. Despite the cast's best efforts, there's no one to root for, with all the high stakes, twists and turns the film throws at us. This holds true for the main character Sue Butters. There's not a moment when the talented and versatile Allison Janney isn't captivating. She commands such a strong presence even when she's meek that you can't take your eyes off her. Sue makes such outlandish decisions at crucial moments that you're left wondering if she deserves to get away with it. With the main plot on thin ice, all the numerous subplots get thinner along with it. An interesting, sometimes amusing dynamic between Karl's brother Patey (Jimmie Simpson) and Rita (Wanda Sykes) who owns the store Patey works at, is often glazé over by the sheer number of characters we don't get to know very well.

The overlapping relationships trigger a series of unfortunate events. But the occurrences get tedious, and the plot twists end up as convenient storytelling rather than logical progressions. None of the character arcs are intriguing, and a few, including those

played by Milla Kunis and Juliette Lewis, are very forgettable and wasted. The lack of humour doesn't help either. Instead, a few violent scenes stick out merely for shock value. For a film with lofty ambitions and a talented cast, particularly Allison Janney, 'Breaking News in Yuba County' lacks a clear tonality or the vision to do justice to its whacky setup.
