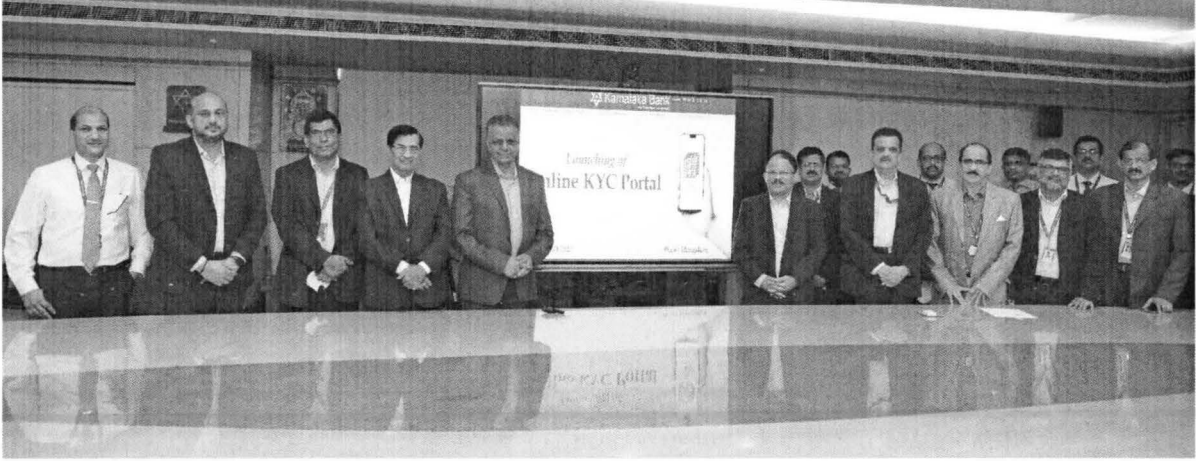

Karnataka Bank launches Online KYC updation portal


