- Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements)
 Regulations, 2015, this is to inform you that in compliance with the regulatory
 recommendations relating to COVID-19 issued by the Central and State Governments, JK
 Paper Limited has temporarily suspended operations at its manufacturing facility Unit CPM
 at Fort Songadh, Gujarat.
- 2. The operations at Unit JKPM at Rayagada, Odisha are being reduced in phased manner in accordance with the directives/permission of the Administrative Authorities in full compliance with the Guidelines relating to safety, health, hygiene, reduced manpower, social distancing and other precautionary measures required to be taken in the prevailing situation.
- 3. Further, The Sirpur Paper Mills Limited, subsidiary of the Company, has also temporarily suspended its operations at its manufacturing facility at Sirpur-Kaghaznagar, District Komarambheem Asifabad, Telangana.
- 4. The Company is closely monitoring the situation and will decide on resumption of operations based on further directives from the Government. The financial impact of the aforementioned suspension of operations is not ascertainable at this stage.
- 5. In our effort to mitigate the challenges posed by COVID-19, the Company has taken all due precautions to safeguard its employees and other stakeholders, including travel restrictions, remote working, social distancing and proper sanitisation of its facilities, workplaces etc. The Company is having continuous touch with its employees to ensure safety and well-being of them and their family members.
