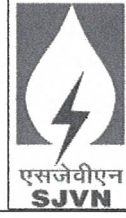

SUB: Clarification/Confirmation on news item appearing in "Media/Publication"

Sir/Madam,

This has reference to the news clarification sought by the Stock Exchanges on the news item appearing in "The Free Press Journal" dated 16th July, 2022, with respect to "SJVN signs contract agreement for two solar projects (125 MW) in Uttar Pradesh".

In this regard, the Company has in its disclosure dated 7th January, 2022, informed about the issuance of a Letter of Intent by UPNEDA for grid connected Solar Power Project. In furtherance of the same, the Company has entered into an EPC (Engineering, Procurement & Construction) Contract for two projects namely 75 MW Solar Project at Gurah District Jalaun and 50 MW Solar Project at Gujrai District Kanpur Dehat with M/s Solarworld Energy Solutions Private Limited end to end delivery of the commissioned Solar Plant including comprehensive Operation and Maintenance of these Solar PV Plants for two years.

Award of contract is just one of the several stages involved in setting up a solar power plant and as such does not have any material impact on the current/future operations of the Company. Hence, the disclosure in the category of material events prescribed under the regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") was not obligatory for this event.

We have made and will continue to make disclosures in compliance with our obligations under Listing Regulations and our agreements with the Stock Exchanges.
