Due to the fire incident, the operations of Line II was suspended and subsequently stopped.

Now the Sharon Bio- Medicine Limited (**material subsidiary of Company**) has completed all the required processes for re-commencement of commercial operations of Line II of manufacturing facility situated at Plot No L6, MIDC Area, Taloja, Panvel, Dist: Raigad, Maharashtra and the commercial operations resumed from March 21, 2024 onwards.

Dear Ma'am/Sir,

As already informed to the stock exchanges, the resolution plan approved by the Committee of Creditors of Sharon Bio-Medicine Limited has already been filed with the Hon'ble National Company Law Tribunal, Mumbai Bench ("NCLT") on November 21, 2022, and the same is currently pending for approval of the Hon'ble NCLT. Upon approval by the Hon'ble NCLT and subject to implementation of the plan, the company is positive that it shall be successfully resolved and will ultimately pave the way towards improved and better business operations, thereby benefitting many stakeholders of the Company including its employees and workmen.

As the matter stands thus, pursuant to Regulation 30 (4) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with Para B of Part A of Schedule III, this is to inform you that a fire accident took place during the morning hours on Sunday, February 26, 2023, at the Company's manufacturing unit located at M/s Sharon Bio-Medicine Limited, Plot No L6, MIDC Area, Taloja, Panvel, Dist: Raigad, Maharashtra thereby as a safety measure, all operations in the plant have been suspended. The situation was brought to control with the help of fire fighters and fire was extinguished but unfortunately one Company personnel has been injured and admitted to the hospital with burn injuries. The Company is providing all the needed medical care and assistance to the employee and current position of injured employee is Stable.

We would like to clarify that the Company has adequate insurance coverage and have already informed the Insurance Company about the incident. The Company is in the process of ascertaining the cause of the fire and actual loss caused due to the fire. Further, Company will keep you posted about the development.
