Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that this is to inform that the Company has received Notice from BSE Limited (BSE) and National Stock Exchange of India Limited (NSE) vide their emails dated 21st November, 2023 and 23rd November, 2023 respectively regarding imposition of fine for non-compliance of provisions of Regulation 17 (1) of SEBI (LODR) Regulations, 2015 for not having requisite number of Independent Directors including Independent Woman Director on the Board for the quarter ended September, 2023, as per the details indicated below:

In response to the above, the Company vide emails dated 22nd November, 2023 and 23rd November, 2023 has represented to both the exchanges for review of fine since IRCTC is a Government Company and the power to appoint Directors including Independent Directors on its Board vests with the President of India, represented through Ministry of Railways, Government of India.

It is to further submit that the Company follows up with Ministry of Railways, Government of India from time to time for appointing requisite number of Independent Directors, including Independent Woman Director on its Board and the matter is
