**Secretarial Compliance Report of
Shri Dinesh Mills Limited for the financial year ended on 31st March, 2024**

We have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by Shri Dinesh Mills Limited, CIN-L17110GJ1935PLC000494 (hereinafter referred as 'the listed entity'), having its Registered Office at Near India bulls Mega Mall, Akota Road, Vadodara – 390020. The Secretarial Review was conducted in a manner that provided us a reasonable basis for evaluating the corporate conducts/statutory compliances and to provide our observations thereon.


