दिल्ली सरकार प्रबंधन में विफल सरकार को भुगतना पड़ेगा।

शहर में थाना साइट- 5 क्षेत्र के ईस्टर्न पेरीफेरल एक्सप्रेसवे पर रविवार की रात को हुई एक सड़क दुर्घटना में सात लोगों की मौत हो गई तथा छह लोग गंभीर रूप से घायल हो गए। एसपी (ग्रामीण) रणविजय सिंह ने सोमवार को बताया कि हरियाणा के जनपद बल्लभगढ़ के रहने वाले जाकिर आसिम, श्रीमती शमशीर, कुमारी रिहाना, कुमारी सुमाइला, कुमारी भूरी उर्फ फरजाना, शबनम, अक्सा, मुशरफ, रुबियान, फरहान, कुमारी सिया एक वैन में सवार होकर बुलंदशहर के गुलावठी में एक शादी समारोह में भाग लेने जा रहे थे। उन्होंने बताया कि रविवार रात करीब नौ बजे ईस्टर्न पेरीफेरल एक्सप्रेसवे पर इनकी वैन को किसी अज्ञात वाहन ने टक्कर मार दी। एसपी ने बताया कि इस घटना में श्रीमती शमशीर, जाकिर, आसिम, कुमारी रिहाना, कुमारी सुमाइला और कुमारी भूरी उर्फ फरजाना की मौत हो गई।

उन्होंने बताया कि इस घटना में घायल कुमारी अक्सा की उपचार के दौरान आज सुबह दिल्ली के राम मनोहर लोहिया अस्पताल में मौत हो गई। सिंह ने बताया कि इस घटना में गंभीर रूप से घायल शबनम, मुशरफ, रुबियान, फरहान और कुमारी सिया को उपचार के लिए दिल्ली में भेज कराराया गया है। घायलों में चार की हालत नाजुक बनी है।

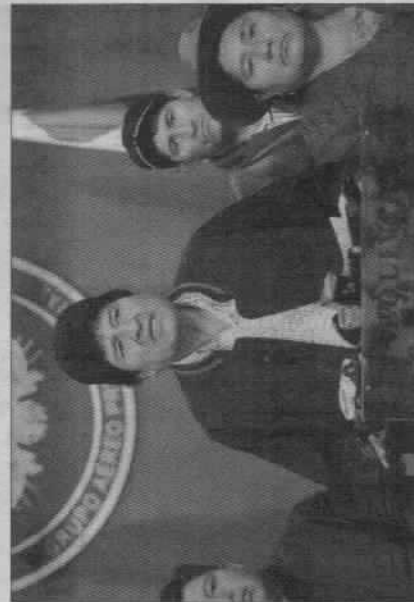

Morales exit in Bolivia sparks violence, political vacuum

BOLIVIA'S CAPITAL La Paz was rocked by violent clashes overnight with buildings set on fire in apparent retaliatory attacks after Evo Morales, the country's president since 2006, resigned under pressure over a disputed election last month.

Morales said on Sunday he would step down to ease violence that has gripped the South American nation since a disputed election, though he stoked fears of more unrest by lashing out at a "civic coup" against him and saying his home had been attacked.

Tensions around the country, which have been simmering for weeks, mounted late into the night amid a political vacuum after Morales, his Vice President and many of his political allies in government stepped down. In the capital and the eastern city of Santa Cruz, crowds cheered the resignation of Morales, who drew ire by running for a fourth term in defiance of term limits before claiming victory in the disputed election.

S Korea Army bans liquid e-cigs on bases

THE SOUTH KOREAN Army has banned the use and possession of liquid e-cigarettes on its bases for health reasons, the military said on Monday, following a government warning for people to stop using the devices.

South Korea has a large military of nearly 600,000 soldiers, primarily conscripted men, and the Army makes up the largest portion with 464,000. While the rate is declining, South Korean men are among the heaviest smokers in the world.

The Health Ministry issued an advisory last month urging people to stop using liquid e-cigarettes citing cases of lung injuries in the United States including fatalities. The ministry said it would conduct studies to determine whether there was a scientific basis to ban the sales of liquid e-cigarettes, which vaporise liquid containing nicotine. A pneumonia case of a 30-year-old South Korean e-cigarette user was reported last month, according to the ministry.
