





दिल्ली की एक अदालत ने चीनी स्मार्टफोन विनिर्माता वीवों के खिलाफ धनशोधन के एक मामले में आरोपी चार लोगों की न्यायिक हिरासत गरुवार को 7 दिसंबर तक के लिए बढ़ा दी। आरोपियों में लावा इंटरनैशनल मोबाइल कंपनी के प्रबंध निदेशक और एक चीनी नागरिक शामिल हैं। अतिरिक्त सत्र न्यायाधीश देवेंद्र कुमार जांगला ने प्रवर्तन निदेशालय (ईडी) की अर्जी पर आदेश सुनाया। गिरफ्तार किए गए चारों लोगों में लावा इंटरनैशनल के प्रबंध निदेशक हरिओम राय, चीनी नागरिक गुआंगवेन उर्फ एंड्रयू कुआंग और चार्टड एकाउंटेंट नितिन गर्ग तथा राजन मलिक हैं। राय की ओर से वकील नीतेश राणा ने न्यायिक हिरासत बढ़ाने के ईडी के आवेदन का विरोध किया और कहा कि 'यांत्रिक रूप से और स्वतः तरीके से यह नहीं किया जा सकता। राणा ने अदालत से कहा 'हरिओम राय के खिलाफ सहयोग नहीं करने के आरोप नहीं हैं।'



नैशनल कंपनी लॉ ट्रिब्यूनल (एनसीएलटी) ने गुरुवार को बंद पड़ी विमानन कंपनी गो फर्स्ट की दिवालिया प्रक्रिया को 90 दिन की मोहलत और दे दी। यह अवधि इस साल 6 नवंबर से शुरू होकर 4 फरवरी, 2024 को समाप्त होगी।इस विस्तार पर विमानन कंपनी के पट्टादाताओं के एतराज को खारिज करते हुए एनसीएलटी ने कहा कि तय अवधि में समाधान योजना पूरी की जानी चाहिए।

ट्रिब्युनल ने विमानन कंपनी के रिजॉल्युशन प्रोफेशनल को 90 दिन की कार्ययोजना जमा कराने को भी कहा है। पट्टादाताओं की दलील का विरोध करते हुए रिजॉल्यूशन प्रोफेशनल ने अदालत से कहा कि दिवालिया प्रक्रिया में विस्तार का फैसला लेनदारों की समिति के दायरे में है और पट्टादाताओं को विरोध करने का कोई अधिकार नहीं है। लेनदार सीओसी का हिस्सा हैं।

कारोबार तिगुना करेगा फिशर समूह

दीपक पटेल नई दिल्ली, 23 नवंबर

निर्माण क्षेत्र के लिए फिक्सिंग सिस्टम और ऑटोमोबाइल कंपनियों के लिए कलपुर्जा बनाने वाला जर्मनी का फिशर समूह अगले 5-7 वर्षों में अपना भारतीय कारोबार तीन गुना होकर 600 करोड़ रुपये ज्यादा होने की उम्मीद कर रहा है।

पिछले तीन साल में उसके भारतीय कारोबार में सालाना 41 फीसदी चक्रवद्धि की रफ्तार से बढ़ोतरी हुई है और यह करीब 200 करोड़ रुपये पर पहुंच चुका है। फिशर इंडिया के प्रबंध निदेशक मयंक कालरा ने यह जानकारी दी।

प्रेस कॉन्फ्रेंस में उन्होंने कहा, अब हम अगले 5-7 वर्षों में करीब 20 फीसदी सालाना की मजबत वृद्धि देख रहे हैं।

साल 2022 में फिशर समूह का सालाना टर्नओवर 1.14 अरब यूरो था और अभी यह भारत समेत 39 देशों में अपनी 51 सहायक कंपनियों के साथ परिचालन कर रही है। हालांकि कंपनी का भारत में उत्पादन केंद्र नहीं है।

कालरा ने स्पष्ट किया कि अभी भारत में उत्पादन केंद्र खोलने की समह की कोई योजना नहीं है। कंपनी अपनी वैश्विक पहुंच का से ज्यादा आयात करती है, जो मुख्य रूप से मध्य



लिए सबसे अच्छे कदम तय कर रही है।

उन्होंने कहा कि कंपनी का सालाना भारतीय कारोबार अगले 5-7 वर्षों में 600 करोड़ रुपये से ज्यादा होने का अनुमान है। उन्होंने कहा, आंतरिक तौर पर हमें अहसास हो रहा है कि हम अपना कारोबार 5-7 वर्षों में तिगुना होने पर बातचीत कर रहे हैं।

इसके अतिरिक्त उन्होंने कहा कि भारत में कर्मचारियों की मौजुदा संख्या 139 है, जो इस अवधि में बढ़कर 400 से ज्यादा होने का अनमान है। कंपनी अपने उतपादों का 80 फीसदी विश्लेषण कर रही है और आने वाले समय के युरोप के अलग-अलग संयंत्रों से आता है। उन्होंने
