अमरावती: शेतकरी आत्महत्याची प्रस्त असलेल्या परिचय विदर्भात कृषी विभागकडून प्रमाणित करण्यात आलेले नामांकित कंपन्यांचे बियाणे न उगवल्याने शेतकरी मोठ्या संकटात सापडला आहे.

सदोष बियाण्यांच्या प्रकरणांमध्ये तालुकास्तरीय समिती स्थापन झालेल्या असून या सदस्यद्वयीय समितीच्या सदस्यांकडून प्रत्यक्ष शेताची पाहणी केली जात आहे. त्यांचे निष्कर्ष आणि अहवाल प्राप्त झाल्यानंतर शासनाकडून योग्याच्या सूचनांनुसार पुढील कार्यवाही केली जाणार आहे.

सदोष बियाण्यांमुळे दुबार पेरणीच्या संकटात सापडलेल्या शेतकऱ्यांना संबंधित बीज उत्पादक कंपन्यांनी जुकसामभरपाई घावी. अन्यथा या कंपन्यांचे कृषी विभागाने कडक कारवाई करावी. असे निर्देश मिळाले आहेत.

विविध कंपन्यांचे बियाणे उगवले नाही, अशा तक्रारी सातत्याने वाढत आहेत. मोसमी पावसाचे आगमन झाल्यानंतर शेतकऱ्यांनी कृषी केंद्रांमधून महागडे सोयाबीन, कपाशीची बियाणे खरेदी करून पेरणी केली. पण या सदोष बियाण्यांमुळे शेतकऱ्यांनी मोठी फसवणूक झाली आहे.

प्राप्त होत होत्याच, पण यंदा हे प्रमाण लक्षणीयरीत्या वाढले आहे. अमरावती जिल्ह्यातून ५९५, अकोला ४७९, वतवाळ ५४९, बुलाडणा १३४ आणि वाशीम जिल्ह्यातील ३३९ अशा एकूण २०८८ शेतकऱ्यांच्या तक्रारी प्राप्त झाल्या आहेत.

गेल्या वर्षी बहुतांश शेतकऱ्यांचे सोयाबीन काढणी होण्यापूर्वीच पावसात भिजले होते. ओले झालेले सोयाबीन पेरणीसाठी वापरता येऊ शकत नाही. त्यामुळे शेतकऱ्यांनी गेल्या वर्षीपेक्षा महागड्या दराने बियाणे विकत घेतले होते.

करोनामुळे वाढल्याचे संस्थेच्या प्रमुख डॉ. सविता पानट यांनी सांगितले. कोणत्याही अनुदानाशिवाय काम करणाऱ्या समाजसेवी संस्थांची अवस्था नाजूक बनली असून, अनुदानित संस्थांनी वेळेवर अनुदान न मिळाल्याने त्यांच्यासमोरही अर्थसंकट उभे राहिले आहे.

एकीकडे 'एचआयव्ही' आणि दुसरीकडे करोना विषाणूची भीती, अशा दुहेरी संकटात असलेल्या 'इन्फंट इंडिया' या स्वयंसेवी संस्थेतील ७० मुलांना यापुढे जगवायचे कसे, असा प्रश्न दत्ता आणि संध्या बारगजे या संस्थाचालकांना पडू लागला आहे.
