We draw your reference to our earlier filings dated 15th September 2022 wherein we had communicated the decision to hive-off the Company's Bus Operations Business Undertaking by way of slump sale on a going concern basis. We had further updated the exchanges on the successful conclusion of the requisite shareholder approval in resect thereof by filing voting results on 31st October 2022, which was also updated on the Company's website. Pursuant to the provisions of Regulation 30 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015, we wish to inform you that the Company has executed 'Business Transfer Agreement' on 29th December 2022.

We wish to further inform that out of the agreed upon consideration of Rs.23,000 lakhs (Rupees twenty three thousand lakhs only) for the said transaction, a sum of Rs.22,500 lakhs (Rupees twenty two thousand five hundred lakhs only) has already been received by the Company and the same has been utilized to reduce debt. The Bus Operations Business Undertaking would vest with the Purchaser w.e.f. 1st January 2023 and Closing of the transaction would happen subject to fulfillment of certain approvals whereupon the balance consideration would also be received by the Company.

Henceforth, the Management would focus solely on its high growth oriented core competency, Goods Transport business, which also entails higher returns.
