

आर्थिक समीक्षा के अनुसार बड़ी फैक्टरियों में काम करने वालों की संख्या और उनकी हिस्सेदारी दोनों बढ गई हैं। महामारी से पहले आंकड़ों के विश्लेषण से जानकारी मिलती है कि देश की फैक्टरियों में लोगों के काम करने की संख्या में बदलाव आ रहा है। हालांकि अभी भी देश में ज्यादातर छोटी फैक्टरियां हैं और इनमें 50 से कम कर्मचारी कार्यरत हैं। मंगलवार को जारी आर्थिक समीक्षा के अनुसार, ' समय गुजरने के साथ बड़ी फैक्टरियों में 100 से अधिक कर्मचारियों को रोजगार मुहैया करवाने का रुझान उजागर होने लगा है। वित्त वर्ष 17 की तुलना में वित्त वर्ष 20 में ऐसी बड़ी फैक्टरियों की

संख्या में 12.7 फीसदी का इजाफा हुआ। हालांकि बड़ी फैक्टरियों की तुलना में छोटी फैक्टरियां कहीं ज्यादा हैं।'

वित्त वर्ष 17 की तुलना में वित्त वर्ष 20 में बड़ी फैक्टरियों में नियुक्त व्यक्तियों की संख्या 13.7 फीसदी बढ़ गई। हालांकि छोटी फैक्टरियों में यह संख्या केवल 4.6 फीसदी बढ़ी। कल फैक्टरियों में बड़ी फैक्टरियों की हिस्सेदारी 18 फीसदी से बढ़कर 19.8 फीसदी हो गई। हालांकि फैक्टरियों में नियक्त कल लोगों के मामले बड़ी फैक्टरियों की हिस्सेदारी 75.8 फीसदी से बढ़कर 77.3 फीसदी हो गई।


