Nagpur (HIndusthan Samachar): The hopes of resolving issues pertaining to on-going strike of employees of Maharashtra Road Transport Corporation, appear dim. The talks with the Transport Minister Anil Parab with the employees union failed to yield any result.

Meanwhile 30 more employees from Nagpur were suspended, taking total number of suspended employees to 94.MSRTC employees

are on strike for the last five days, in support of their demands.

The major demands include merger of MSRTC into State Government and granting status to employees as government employees; parity of wages with government employees; regular payment of salaries etc.Following discussion Parab has stated that the solution will be worked outy only as per the court orders.
