While complying with the directions issued by Central Government/State Government with a view to prevent the spread of COVID-19 pandemic the company had temporarily shut down all its offices since March, 2020 to ensure the safety and wellbeing of its employees, customers and all stakeholders and during the lockdown period we have timely updated our investors / stakeholders about the temporary lockdown. The operations at our Goa location have partially resumed with reduced staff and with all precautionary measures as per the orders issued by the Goa Government.

However, the company is in the process of assessing the future impact of COVID-19 pandemic on its business and its subsidiaries operations, profitability, liquidity position and revenue etc.

In terms of SEBIcircular no.SEBI/HO/CFD/CMD1/CIR/P/2020/84 dated May 20, 2020, the Company will intimate/update the impact of COVID-19 pandemic on the business, performance and financials, both qualitatively and quantitatively, to the extent possible and disseminate on the Stock exchange in due course in its Financial Statements.
