In terms of Regulation 30 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015, this is to inform you that the Rights Issue Committee of the Board of Directors of the Company in their meeting held on May 9, 2022, has allotted 60,383 fully paid-up Equity shares on which the final call money of Rs.12 per share has been received. Further 60,383 equity shares of Rs.6 each allotted earlier under ISIN IN9324L01011 stand cancelled.

The aforesaid allotted shares will rank pari passu with the existing fully paid-up equity shares and shall be available to trade under the ISIN INE324L01013 subject to completion of necessary corporate actions and receipt of listing and trading approvals from the Stock Exchanges.


Post allotment as stated above, the paid-up equity share capital of the Company is Rs.37,42,70,236 (Rupees Thirty Seven Crores Forty Two Lakhs Seventy Thousand Two Hundred and Thirty Six only) divided into 3,67,46,683 (Rupees Three Crores Sixty Seven Lakhs Forty Six Thousand Six Hundred and Eighty Three only) fully paid up equity shares of Rs.10 each and 11,33,901 equity shares partly paid up (Rs.6 paid up).
