Mining resumes in Goa after 6 years; Vedanta begins ops

PRESS TRUST OF INDIA New Delhi, April 4

MINING IN GOA resumed after a gap of six years, with mining major Vedanta on Thursday announcing that it has commenced operations at Bicholim Mineral Block in the state.

Bicholim Mineral Block is the first auctioned mine to become operational since 2018 when the Supreme Court imposed a blanket ban on mining in the coastal state, the company said.

The mining in Goa came to a grinding halt in March 2018 after the Supreme Court quashed 88 mining leases.

"Heralding a new era of inclusive development, Vedanta Sesa Goa commenced mining operations at Bicholim Mineral Block Block 1 in the state of Goa, the company said in a statement.



Vedanta Limited had in 2022 emerged as a successful bidder for the mining block which was auctioned.

RBI defers forex derivatives rules

THE RBI HAS mandated that traders should compulsorily have an underlying contracted exposure to foreign currency if they want to trade in the currency derivatives segment.

Experts said that there was a desperation in the market to unwind their currency derivatives positions but several traders were unable to do so due to lack of liquidity.

"There was still decent open interest left in currency futures and options market. As most of the brokers started informing clients an exiting positions post the exchange's circular on April 1, it had made the market one-sided and due to lack of liquidity clients were facing high impact cost," Abhilash Koikkara, head - forex & Commodities, Nuvama professional clients group, told FE.

Regarding the circular, RBI said it sets out the Master Direction and reiterates the regulatory framework for participation in ETCs involving the rupee without any change.

From the brokers' side, it will also help traders who still have positions in April maturity contracts to let the contracts expire if they do not find adequate liquidity to exit.

"The board has approved the initial public offering for the hospitality business, and they are actively working on it," the sources said.

"Prestige will be the majority shareholder after the listing," they said.

An email sent to the company did not elicit any response.

Last month, Prestige and global hotel company Marriott International inked a deal to develop six hotel projects across India, including Karnataka and Goa, over the next two to three years.

The total inventory will be 801 keys across Goa and Karnataka and Marriott is launching some of the new brands in the country with Prestige. Prestige is investing around ₹1,000 crore in the new hotels with Marriott.

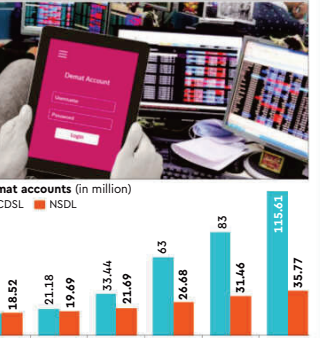
