लबाजवाणी करण्यात येत आहे. प्रकल्पासाठी जिल्हा नियोजन समितीमार्फत ₹९ लक्षा ६१ हजार रुपयांची तरतूद करण्यात आली आहे. जिल्ह्यात महाराष्ट्र राज्य ग्रामीण जीवनोन्नती अभियान-उमेद अंतर्गत २०१९ मध्ये ८ हजार ३४२ स्वयं सहायता समूहांची स्थापना झाली असून जिल्ह्यात २४ हजार ४४९ स्वयं सहायता समूह आहेत. जिल्हा परिषदेअंतर्गत ७० गटात स्वयंसहायता समूहामार्फत व्यवसाय सुरू करण्याच्यादृष्टीने सावित्रीबाई फुले पुणे विद्यापीठाच्या नवोपक्रम, संशोधन व साहचर्य केंद्राचे सहकार्य मिळणार आहे. स्वयं सहायता समूहाच्या सदस्यांना उद्योजकतेचे प्रशिक्षण देणे, खरेदी, उत्पादन तयार करणे, मूल्यसाखळी तयार करणे, प्रकल्पाचा प्रस्ताव तयार करणे, प्रस्तावाचा पाठपुरावा करून शासकीय विभाग आणि बँकेकडून आर्थिक सहाय्य मिळवून देणे, मूल्यवर्धित साखळी तयार करून बँक जोडणी आदी बाबींचा यात समावेश असणार आहे. या बाबींची विविध टप्प्यात जोडणी करण्यात येणार आहे.
