The said Notice was also uploaded on the websites of the Company at <u>www.groupaki.com</u> and Stock Exchanges i.e. National Stock Exchange of India Limited at <u>www.nseindia.com</u> and BSE Limited at <u>www.bseindia.com</u> along with shareholders' facility to exercise their right to vote on the resolution contained in the Notice calling the Meeting using an electronic voting system before the Meeting on the dates referred to in the Notice and after the Meeting;
- 4. The said appointment as Scrutinizer is under the provisions of Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended ("the Rules"). As the Scrutinizer, I have to scrutinize process of remote e-voting.

5. Management's Responsibility

The management of the Company is responsible for ensuring compliance with the requirements of (i) the Act and the Rules made thereunder; (ii) the MCA Circulars; and (iii) the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, ("LODR") relating to e-voting on the resolutions contained in the Notice calling the EGM. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.

6. Scrutinizer's Responsibility

My responsibility as Scrutinizer for the e-voting process (i.e. remote e-voting) is restricted to making a Scrutinizer's Report of the votes cast in "favour" or "against" the resolution contained in the Notice, based on the reports generated from the e-voting system provided by National Securities Depository Limited, the Agency authorized under the Rules and engaged by the Company to provide e-voting facility.

The remote e-voting period remained open from Friday, 19^{th} May, 2023 at 9:00 A.M. and ends on Sunday, 21^{st} May, 2023 at 5:00 P.M.

The votes cast during the remote e-voting were unblocked on Tuesday, 23rd May, 2023, after the conclusion of the EGM and were witnessed by two witnesses, who are not in the employment of the Company.
