

- III. The objects for which the Company is established are as under :

MAIN OBJECTS OF THE COMPANY TO BE PURSUED ON ITS INCORPORATION: (A)

- To carry on the business of manufacturers, dealers, importers, exporters of pharmaceutical chemicals, fine chemicals, agrochemicals, chemical products of every nature and description and compounds, intermediates derivatives and bye-products thereof and products to be made therefrom (hereinafter for convenience referred to generally as "chemicals and chemical products") including specifically, but without limiting the generality of the foregoings, calcium carbide, calcium cyanamide, lime, nitrogen, oxygen, enitrogeneous compounds, fertilizers, acids, alkalies, sizes, oils, metallurgical reagents, flotion reagents, wetting agents, insecticides, pesticides and fungicides, dyestuff, explosives, catalytic agents, serums, vitamin products, hormones, sutures, ligaturers for use in the prevention, treatment or cure of disabilities in men or animals and products derived from phosphate mines, lime stone, quarries, bauxite mines, petroleum, natural gas and other natural deposits, useful or suitable in the manufacture of chemical and chemical products as hereinabove defined.
- To carry on the business of importing, exporting, prospecting and boring for extracting, pumping, drawing transporting, refining and dealing in natural gases, petroleum and other minerals, oils and fuels and/or manufacturing of all kinds of petroleum products and bye-products.
- To manufacture, produce, use, buy, sell, import and export and otherwise deal or traffic in any or all inorganic and organic chemicals, including alidhatic or aromatic types, solvents, intermediates dyestuffs, drugs, medicines and pharmaceuticals, antibiotics, fermentation products, reagents, textile auxiliaries, catalysts including raw materials required for the manufacture thereof.

- To design, develop, engineer, import, export, buy, sell and otherwise deal in licence, grant any rights in fabricate, hire out, lease, technical know-how, plant, machinery and equipment relating to manufacture, processing, storing or transport of all kinds of chemicals, plastics and resins, whether processed or not and their bye-products.
- 3. To enter into arrangement for technical collaboration and/or other form of agreement including capital participation with foreign or Indian manufacturers of products which the Company is empowered to manufacture or any products manufactured or proposed to be manufactured or processed by the Company and to pay for such technical assistance or collaborations, royalties or other fees in cash or by allotment of equity or other capital of the Company credited as paid up or issue of debentures or debenture stock.
- 4. To do all or any of the above things in any of the world as principals, agents, trustees, contractors and by or through agents, sub-contractors, trustees or otherwise and either alone or in conjunction with others.
- 5. - 6. - To undertake, carry out, promote and sponsor or assist any activity for the promotion and growth of the national economy and for discharging what the Directors may consider to be social or moral responsibilities of the Company to the public or any section of the public as also any activity which the Directors consider likely to promote national welfare or social, economic or moral uplift of the public or any section of the public and in such a manner and by such means as the Director may think fit and the Directors may without prejudice to the generality of the foregoing, undertake, carry out, promote and sponsor any activity for publication of any books, literature, newspapers or for organising lectures or seminars likely to advance these objects or for giving merit awards for giving scholarship. loans or any assistance to deserving students or other scholars or persons to enable them to pursue their studies and academic pursuits or researches or for establishing, conducting or assisting any institution, fund, trust having any one of the aforesaid objects by giving donations or otherwise in any other manner and the Directors may, at their discretion, in order to implement any of the above mentioned objects or purposes transfer without consideration or at such a fair or concessional value as the Directors may think fit and divert the ownership of any propetty of the Company to or in favour of any public or local body or authority or Central or State Government or any Public Institutions or Trusts or Funds or Organisation(s) or person(s) as the Directors may approve.

- 8. In event of winding up to distribute any of the property of the Company in specie among the members subject to Section 205(3) of the Companies Act, 1956.
- To draw, make, accept, endorse, discount, execute and issue bills of exchange, promissory notes, bill of lading, warrants, debentures and other negotiable or transferable instruments of securities.
- To undertake and execute any, the undertakings of which may seem to the Company desirable, gratuitously or otherwise.
- 11.  - (c) To carry on the business as quarry and stone merchants and to buy, sell, import, export, supply, get work, hew. carve, polish, prepare for market or use stone of all kinds.
 - (d). To purchase, take on lease or on royalty basis or otherwise, acquire mines, mining rights and lands and any interest therein.

 - (a) Pipes, tubes, hoses, reinforced hoses, rods and such other extruded articles of every kind and description made of plastics, rubber, yarn, both synthetic and natural raw materials.
 - (b) Plastic moulding powders of high and low density, polythene, polystyene, PVC powders, resins, compounds, acetate, rayon, yarns, dyes, benzyl, acrylic, buterate, nylon, bakelite and such other varieties.
 - (c) Plastic laminations of every kind and description.
 - (d) Moulded articles by different moulding processes such as injection, blow, vaccum forming act processes.
 - (e) Polythelene layflat tubings, sheets, bags.
 - (f) Electrical, automobile articles or accessories form plastics Bakelite, nylon, polypropylene and other group powders.
- 17. To carry on the business as capitalists, concessionaries, merchants, traders, commission agents, selling agents, importers, exporters, suppliers, business of hire-purchase and to carry on and execute all kinds of financial, industrial, commercial, trading operations (excluding Banking and Insurance Business) which may seem to be capable of being conveniently and/or advantageously carried on or in connection with any object of the Company.
- 18. To carry on the business as general merchants, importers, exporters, wholesalers, retailers, shop-keepers, agents, commission agents, brokers, jobbers, financiers, selling and purchasing agents, hirers, manufacturer's representative, agents for foreign or local firm or companies or associations or other corporate or incorporation bodies and generally as dealers and processors in all kinds of commodities or articles whether raw materials or manufactured articles and whether in a finished or semi-finished state.

- 19. To carry on the business of manufacturers, seller, distributors, exporters, importers of and dealers in all kinds of automobiles, motor cars, trucks, lorries, transport vehicles, cargo vehicles, tempos, tractors, tractor trailers, scooters, motor cycles, cycles, machines, machineries of all kinds and all parts, spares, accessories and ancillaries used or required for or in the manufacture or sale or distribution or use of all such automobiles, motor cars, trucks, lorries, transport vehicles, motorcars, cargo vehicles, tempos, tractor trailers, scooters, motor cycles, machines and machineries connected therewith or related thereto or in or for allied industries.
- 20. To develop, manufacture, sell, export and otherwise deal in heat exchangers viz. radiators, radiator cores, grilled tubes, thermostats and all components of radiators, air coolers, oil-coolers, intercoolers and all components of such equipment for all applications including automobiles, trucks, tractors, industrial engines, air compressors, electric motors, locomotives, electric transformers and any other mechanical or electrical equipments.
- 21. To carry on business of manufacturing, buying, selling, supplying, importing, exporting and otherwise dealing in all kinds of industrial machinery, equipments, apparatuses, instruments and parts thereof including engineering, electrical, chemical, paper manufacturing, textile and other machinery, plants, equipments, apparatuses, instruments and parts thereof and accessories, fittings, components and spare parts in respect thereof, implements, tools and hardware of all descriptions, alloys and ferrous and non-ferrous metals, special steels, engineering and electrical goods and products and resins chemicals, dyes, wood pulp and other kinds of pulp for rayon and paper industries and other kinds of raw materials, commodities, products and things.
- 22. To purchase or take on lease or mortgage or hire mines, mining rights and metaliferrous land in India or elsewhere or otherwise acquire mining lease for limestone, clay, bentonite, felspar, magnesium or any materials believed to contain chemical substances and to excavate, explore, manipulate, alter, improve and develop or market or make such mines and such materials.
- 23. To carry on the business of things, articles and commodities of any description whether by mechanical or chemical process or processes, using cement, limestone, felspar, chalk-powder, china-clay, fire-clay, barytes, rock-phosphate for use in agriculture and fertiliser and allied applications, gypsum magnesium, bentonite, calcite, coal, lignite, bauxite, rare earth or any other material believed to contain mineral, saline or chemical substances as basic raw material.
- 24. To search' for, get work, raise, make marketable, sell and deal in iron, coal, iron stone, manganese, ferro manganese, clay, fire clay brick earth, bricks and other metals, minerals and substances and to manufacture and sell briqubettes and other fuel and generally to undertake and carry on any business, transaction or operation commonly undertaken or carried on by explorers, prospectors and concessionaries and to search for win, work, get, calcine, reduce, amalgamate, dress, refine, market, quartz and mineral substances and to buy, sell, manufacture and deal in mineral products, plant and machinery, capable of being used in connection with mining metallurgical operation of required by the workmen and others employed by the Company.
- 25. To work mines or quarries and to prospect for, search for, win, cursh, smelt, calcine, concentrate, refine, dress, amalgamate, beneficate, pelletise, manipulate, prepare for market or other exploit, import or deal in metals and metallic and non-metallic minerals of all kinds including flourspar or flourite, bauxite lime stones, precious and other stores to carry out all kinds of mining and metallurgical operations and to carry on the business of manufacture in metals and metallic alloys including special alloys of all kinds and to maanufcture galvanised and plated and clad iron and steels as well as other metal of all kinds.
- 26. To carry on business of manufacturing, compressing and distribution of oxygen, hydrogen, carbonic, acid, acetylene and any other gases of kind and substances or any compounds or preparations thereof prepared by any process and of selling, distribution of applying such gases, substance, compounds or preparation of any of them to such purposes as the Company may from time to time think fit and to manufacture, buy, sell, let on hire, deal in engines, electronics, transformers, gas cylinders, compressors, welding machines, arc lamps and any other useful apparatus equipments and conveniences which are useful in consumption distribution and utilisation of gases.

- 27. - 28. - 29. To carry on business of manufacturing, buying, selling, exchanging, converting, altering, importing, exporting, processing, twisting or otherwise handling or dealing in rayon yarn (also known as continuous filament rayon or artificial silk yarn and which expression shall include all synthetic fibre or fibres whatsoever for textile use), staple fibre, staple fibre yarn (also known as spun rayon) and such other fibre, fibres or fibrous materials or allied products, bye-products or substances or substitutes for all or any of them or yarns for textile or other use, as may be practicable or deemed expedient.
- 30. To carry on the manufacturing, business of electrical engineers, contractors, manufacturers, constructors of electrical and other appliances, cables, wire lines dry cells, accumulators, lamps and works and to generate, accumulate distribute and supply electricity for the purpose of light, heat, motive power and all other purposes for which electrical energy can be employed and manufacture all apparatus and things required or capable of being used in connection with the generation, distribution, supply, accumulation and exployment of electricity including in the term electricity, all power that may be directly or indirectly derived therefrom or may be incidentally hereafter discovered on dealing with electricity.
- 31. To carry on business as manufacturers and processors and dealers in ferrous and non-ferrous metals, woods, enamel, alluminium, all kinds of machine tools, like lathes, milling machines, hobbing and pinion cutting machines, electroplating and all plating and polishing equipments, alloys and other products, substances, articles and things of every description and kind and to carry on all or any of the businesses of engineers, iron brass and other metal founders, machinists, tool makers, wire drawers, tube, pipe and tank manufacturers, moulders, metallurgist and metal workers, fitters, millwrights, galvanisers, grinders and tool sharpners and japyonhers and to buy, sell, export, import, manipulate and deal both wholesale and retail in products, commodities, goods, articles and things of all kinds whatsoever.
- 32. To buy, sell, manufacture, refine, prepare, crush and deal in all kinds of oil and olegenous and sponaceous substances and all kinds of by products or ingredients thereof.
- 33. To carry on the business of importers, exporters, sellers, buyers, distributors, agents or otherwise dealers in all types of commodities, crops, raw materials, semi and manufactured products and goods and ware, plant and machinery, tools and equipments, all kinds of oils, oilcakes, rice, bran and other oil containing medias, deoiled cakes, deoiled meals for human consumption, balanced food, baby and sea foods of all varieties, fresh, preserved, dry fruits and vegetables, beverages, carned

- provisions, tea, coffee, tobacco and tobacco products, all types of fabrics made from natural or artificial fibres or a blend of natural artificial fibres, garments, hosiery apparel, raw cotton and cotton products, raw jute products, raw wool and wool products, raw silk and silk products, textiles, made out of natural and artificial fibres, handloom textiles, cottage industries ware, cotton waste, minerals and ores, mica, ferrous and non-ferrous metal products, spicies, footware and leather ware, tanned hides and skins, PVC leather, cloth, article or leather, hessain, tarpaulins, canvas, timber, plywood, veeners. improved and reconstituted wood, floor covering including carpets, paper, boards, handicrafts, curious, automobiles and trucks, diesel engines, pumps, agricultural machinery and implements, ghamellas, electric motors, transformers, switchgears, transmission and V belts, castiron/polythene/galyanised. mildsteel/soil pipes and accessories, manhole covers, any type of castings, building/material and hardware, including sanitary plumbings, glassware, pottery, tableware, scientific instruments, cutlery, made of metal and silver, curry powder and paste, protein, pluse, yeast and phosphaids, hydolysate, protein grains, groundnuts, protein soaps, perfumery and cosmetics, musical instruments, industrial packing materials, containers, stores, machineries, equipments, tools and hardware, dyes and chemicals, colours, paints, varnishes, books and stationery items, cycle/bicycle/auto scooters/cars/ trucks/motor cycles and their components including tube and tyres, cords, typewriters, refrigerators, office furniture and equipment, containers and appliances.

- 48. - 49. - 55. To manufacture, deal in, purchase, sell, import and carry on the business of paints, varnishes, chemicals, distampers, colour, synthetic resins, synthetic thinners, paints, pigments, printing inks, wallpapers, oil barrels, industrial and decorative paints, white lead, linseed oil, glazing materials.

- 69.
