SOFTENING RETAIL DEMAND TO BLAME

June passenger vehicle sales growth down to 2%

May recorded 16% growth in sales

AFTER STELLAR performance in May, wholesale dispatches of cars and SUVs in June slowed down following closure of production...

The passenger vehicle (PV) market is estimated to have clocked sales of 327,700 in June, a growth of 1.9% compared to 321,600 clocked in June 2022.

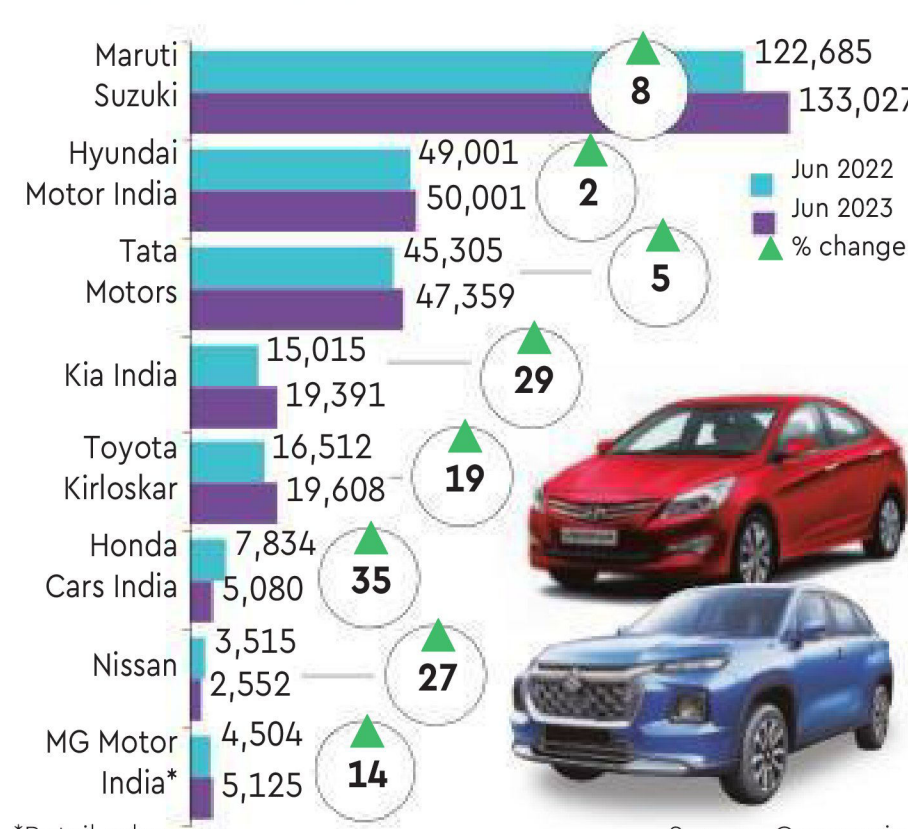
Retail volumes are estimated to have stood at 329,000 during the reporting month as against 301,000 units clocked in the same month last year.

May recorded growth of 16% in volumes which was the best since January, buoyed by strong growth in the rural market where marriage season led to the demand spurt.

Delhi-based Maruti Suzuki India clocked a growth of 8.4% in June to 133,027 units compared to the same month last year.

Shashank Srivastava, senior executive officer, marketing and sales, Maruti Suzuki, said, "Rural markets

The Japanese auto brand grew its volumes by 19% to 19,608 units during June compared to the same month last year.

Atul Sood, vice president of sales and strategic marketing at Toyota Kirloskar Motor, said, "The commencement of three shift operations has played a vital role in enhancing operational capabilities and addressing the growing demand for our products."

Kia India saw its volumes grow by 29% to 19,391 units during June. The company is preparing to launch a revamped version of its flagship Seltos next week.

Hardeep Singh Brar, national head, sales and marketing, Kia India, said, "Kia India is growing faster than the industry."

"We have kept our performance steady with healthy growth, despite the realignment of our manufacturing process to accommodate the development of the new Seltos this month."

The market leader, however, highlighted that semiconductor availability is set to improve in the July-September period compared to the April-June quarter where it is estimated to have lost around 38,000-45,000 units in production. "You can expect production to be better in the second quarter from Maruti Suzuki," Srivastava added.

With the opening of the bookings for the Invicto, Maruti Suzuki claims to have a total pending bookings of 355,000 units.

Korean car brand Hyundai recorded one of the slowest growths during June. The company grew its sales by 2% to 50,001 during the reporting month.

Tata Motors sales grew by 5% to 47,539 units during June compared to the same month last year.

CIL to meet output target this fiscal, says CMD PM Prasad

PM PRASAD, WHO assumed the charge of chairman-cum-managing director of state-run Coal India (CIL) from Saturday, said the firm would achieve the 780 million tonne output target for this fiscal with "all efforts and means available at its disposal".

"On supply side, ensuring uninterrupted coal flow to the power sector is another priority area," Prasad said, according to a stock exchange filing by CIL. Before donning the mantle of Coal India's top post, Prasad was holding charge of CMD of Jharkhand-based Central Coalfields (CCL), a CIL arm, from September 1, 2020.

He began his career at Coal India, the world's largest coal mining company, in 1984 as a management trainee at Western Coalfields and served in different capacities across different CIL subsidiaries. He also had a three-year stint at NTPC as an

executive director (coal mining), Prasad's predecessor Prasad Agrawal relinquished charge as CMD of Coal India with effect from Friday on attaining superannuation. Notably, the miner, which accounts for around 80% of India's annual coal output, is targeting production of 780 MT in the current financial year. The ministry of coal has finalised the total coal production target of 1,012 MT for FY24. During the last fiscal, the coal behemoth's production stood at 703.2 MT, registering a 12.9% growth

year-on-year. CIL on Saturday said bolstering the 780 MT target chase, production during the first quarter of this fiscal shot up to 175.5 MT, the highest recorded during first quarter of any year, with near 10% growth.

During the quarter, expansion in volume was 15.7 MT, which was significant as it came over a high base of 159.8 MT in similar quarter previous fiscal. Production for the month of June at 58 MT grew by 6.4 MT, posting a double digit growth of 12.4% compared to 51.6 MT in June, 2022. "Output could have been even higher but for the heavy rainfall in the last week of June across our mining areas," said a senior executive of CIL. Coal India's over burden removal continued its runaway pace as the firm excavated 497.5 million cubic metres of OB during April-June 2023 period with the comparative period growth hovering high at around 30%.

NTPC captive coal output doubles in Q1

NTPC on Saturday said coal production from its captive mines grew 99% to 8.48 million metric tonne (MMT) in the first quarter of FY24 as compared to 4.27 MMT achieved in Q1 FY23. The coal despatch during the quarter shot up 112% to 8.82 MMT in Q1 FY24 as against 4.17 MMT a year ago, the company said.

India's largest integrated power producer said that the company, which contributes one-fourth of the country's power requirement, will continue to explore innovative technologies and sustainable practices to further enhance its performance. FE BUREAU
