# With 69% return, Paytm leads new-age stock rally

## PolicyBazaar and Zomato have surged 47% and 28%, respectively, this year

Consumer tech companies are luring back investors as they refocus on profitability with digital payments leader Paytm leading a \$6 billion rally among peers so far this year. Shares of Paytm parent One 97 Communications have surged 69 per cent, adding more than \$27 billion in market value, after it improved its Q1 stability ahead of schedule. Food delivery platform Zomato and Policybazaar operator PB Fintech have surged 28 per cent and 47 per cent, respectively, adding over \$1 billion each to their market valuations.

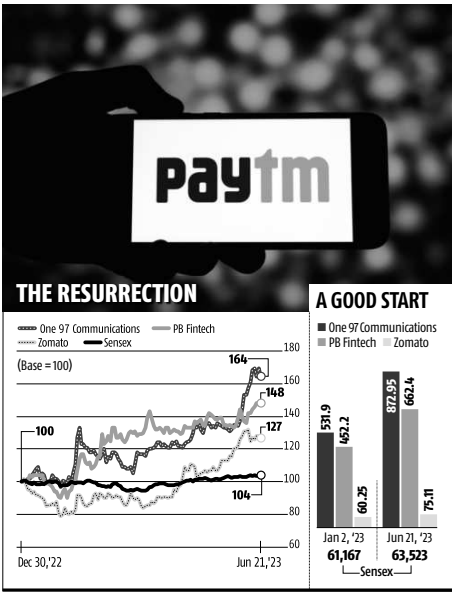
A big push for India's tech unicorns in 2021 from government efforts and high-profile investors including Jack Ma and Masayoshi Son gave way to a global selloff in the sector last year on concerns of higher rates and recession. The collapse in stocks and some disappointing market debuts forced changes.

"The companies realised they had no option but to make profits or at least have a roadmap," said Vikas Gupta, chief investment strategist at Omnicash Capital in Mumbai. "They are not only focusing on turning profitable but have slashed costs and exited businesses that were not promising."

The rebound in India's new-economy stocks followed a bounce in global tech shares, with the Nasdaq 100 up 38 per cent this year, erasing its decline in 2022. While macro concerns have hardly dissipated, the sector has regained its pandemic safe-haven status, helped in part by enthusiasm for the promise of artificial intelligence and other emerging technologies.

Paytm and its cohort have gained even as shares of the Q1 guard of IT service providers including TCS, Tata Consultancy Services and Infosys remain mired in concerns over global economic weakness. The rally in new-age tech stocks has also defied concerns over the financial health of formerly high-flying startup Byju's.

Even with the gains this year, shares of Paytm still trade roughly 60 per cent



below their IPO price in November 2021. Analysts remain confident of the company's ability to earn profits, however, with 85 per cent having a 'buy' recommendation or a 'strong buy' recommendation all-time low in late April.

FSN E-Commerce Ventures, the owner of beauty e-retailer Nykaa, is also still under water, but the stock has climbed back 37 per cent from its all-time low in late April. Analysts have gained

optimism on its potential to expand its fashion business as well as potential partnerships with global brands seeking to go in India.

"These companies have gone through a period of consolidation and re-looked at some of their business models to focus more on profitability," Morgan Stanley strategist Ridham Desai said in an interview with Bloomberg Television last week.

their own homes and want to protect both the structure and their belongings," says Ghosh.

## Determining the sum insured

When deciding the appropriate sum insured for the building and contents, give careful consideration to factors such as house type, location, and the value of your assets.

For the structure, the sum insured can be calculated by multiplying the built-up area by the cost of construction per square foot at the time of policy purchase. For example, if the property is of 1,000 square feet and the construction rate decided by the insurer is ₹1,500 per square foot, then the sum insured should be ₹15 lakh.

As for the contents, Tarun Mathur, co-founder & chief business officer, general insurance, PolicyBazaar, says, "The sum insured for the contents in the house is based on the actual cash value (ACV) of the assets, or the current market value minus the depreciation based on usage."

## Inexpensive cover

This is not an expensive form of insurance (see premium rates in the table). Mathur says, "The calculation of the premium amount depends on a variety of parameters, such as the house's age, structure type, cost of construction, etc."

For many people, their home is the most expensive asset they own. "Such perils can cause extensive damage, leading to a heavy financial burden. Home insurance is a fundamental tool that can provide financial protection — both to your home and its contents," says Gurdeep Singh Bhatia, national head, retail non-motor underwriting and co-insurance, Bajaj Allianz General Insurance.

A comprehensive home insurance plan can mitigate the losses caused by a variety of hazards: floods, cyclones, hurricanes, earthquakes, hailstorms, and landslides.

## Two types of covers

Home insurance policies offer structure and content insurance. "Structure insurance protects the physical structure, including the walls, roofs, foundation, fixtures, and other vital components. It compensates you for the cost incurred in repairing or rebuilding the house in case of damage," says Rahul M. Mishra, co-founder and director, PolicySense.

Content insurance, on the other hand, provides coverage to home appliances, furniture, fixtures, and other valuable possessions. Parthani Ghosh, HDFC Ergo General Insurance, says, "This policy is especially meant for tenants who live in a rented house and are vulnerable to damage to their belongings in case of theft or a natural disaster. It is a must-buy cover for people who have valuable assets in their homes."

Furthermore, a comprehensive insurance is also available which provides protection to both the structure and contents. "It is suitable for people who live in



## Buy a reinstatement policy

Keep in mind a few crucial points when buying a cover for the structure. Kapil Mathur, co-founder and chief executive officer, SecureNow says, "Specify that you want this policy on a reinstatement basis (and not on market value basis) so that it pays for restoring the house to its original state and does not deduct for depreciation."

Ghosh suggests buying a long-term policy that comes with an in-built discount and frees customers from the hassle of remembering the renewal date.

Mehta adds that those who have a basement or a terrace must explicitly mention this at the time of purchase.

## Must buy in disaster-prone areas

Understand the finer details of the policy you are buying, Mishra says, "Understand the coverage, the exclusions, and other policy terms and conditions." Customers should also check if the policy offers any useful add-on features. Some of the ones available are loss of rent, temporary resettlement cover, public liability, lock and key replacement cover, etc.

According to Mathur, in areas susceptible to natural disasters, people must buy a comprehensive home insurance policy along with tailored add-ons. Nowadays, many housing societies buy this type of insurance and collect the premium cost through the maintenance fee, so do check if your society does so.
