EXPLANATORY STATEMENT (Pursuant to Section 102 of the Companies Act, 2013)

Based on the recommendation of the Nomination and Remuneration Committee of the Company, the Board of Directors at its meeting held on 25th February, 2021, had appointed Mr. Virendra G. Bhatt (DIN: 02343351) as an Additional Non-Executive Independent Director of the Company.

As per Regulation 17(1A) of the Listing Regulations, with effect from April 1, 2019, no listed company shall appoint or continue the directorship of a Non-Executive Director who has attained the age of 75 (Seventy Five) years, unless a Special Resolution is passed to that effect and justification thereof is indicated in the explanatory statement annexed to the Notice for such appointment.
